Mayor Jennifer Wilson stated Pete Buttigieg, United States Secretary of Transportation, visited Salt Lake County on July 29, 2022, where he announced the Federal Government has created a new program to address transportation issues using the American Rescue Plan Act (ARPA) funds. This is a great opportunity for Salt Lake County. Ms. Helen Peters, Director, Regional Planning & Transportation

Division, will be looking into ways to apply for these funds.

Also, she is thrilled to announce the debt obligation on the homeless resource centers has been paid off largely due to the State and the County contributing funds for this purpose.

Mr. Darrin Casper, Deputy Mayor of Finance and Administration, stated the payoff was \$16.4 million, with \$5.8 million coming from the State. The relief for Shelter the Homeless is \$3.8 million annually. The net value savings was \$887,000.

Mr. Harris Simmons, President, and Board Chair, Shelter the Homeless, thanked everyone for their willingness to do this. The payoff puts Shelter the Homeless in a much better position.

ORDINANCE NO. 1900

AN ORDINANCE OF THE LEGISLATIVE BODY OF SALT LAKE
COUNTY, UTAH AMENDING SECTION 9.04.030 OF THE SALT LAKE
COUNTY CODE OF ORDINANCES, 2001, ENTITLED “SALT LAKE
COUNTY BOARD OF HEALTH - MEMBERSHIP” BY MODIFYING
MEMBERSHIP REQUIREMENTS FOR THE SALT LAKE COUNTY
BOARD OF HEALTH

The County Legislative Body of Salt Lake County ordains as follows:

SECTION I. The amendments made herein are designated by underlining the new substituted words. Words being deleted are designated by brackets and strike-through.

SECTION II. Section 9.04.030, of the Salt Lake County Code of Ordinances, 2001 is hereby amended to read as follows:

9.04.030 - Membership

The Salt Lake County board of health shall consist of fifteen members residing in Salt Lake County, including: a member of the ~~[county council]~~ Salt Lake County Council selected by the County Council and fourteen other members, appointed by the ~~[county mayor]~~ Salt Lake County Mayor with advice and consent of the ~~[e] County [e] Council~~.

A. Board members shall be appointed on a nonpartisan basis and include geographical representation from ~~[both the incorporated and unincorporated areas of]~~ throughout the county. Members should have knowledge of an interest in public health and environmental matters and shall include:

1. A physician or surgeon licensed in the state;
2. A dentist licensed in the state;
3. A health care professional licensed in the state;
4. A non-health care professional licensed in the state;
5. Two representatives of the public not representing or connected with the regulated business community;
6. A representative of the regulated business community;
7. A mayor representing a municipality in the county [~~;~~]

B. ~~[Any potential conflict of interest of any member shall be disclosed in accordance with applicable statutes and county wide policies and~~

~~procedures]~~ Board members shall comply with Salt Lake County Ethics Code, Salt Lake County Ordinance, Chapter 2.07, and countywide policies regarding conflicts of interest and disclosure statements.

C. Board members shall serve for a term of three years, and their terms shall be structured, as possible, so that one-third of the terms of office of those serving on the board expire each year. The board shall adopt bylaws governing the ~~election~~ selection of its officers, the transaction of its business, and all other necessary matters that are consistent with the Utah Local Health Department Act and Salt Lake County Ordinances. [committees, task forces and other advisory bodies to the board. The board member' terms of service shall be governed by state law.]

SECTION III. This ordinance shall become effective fifteen (15) days after its passage and upon at least one publication in a newspaper published and having general circulation in Salt Lake County.

A RESOLUTION OF THE SALT LAKE COUNTY COUNCIL
AGREEING TO THE CREATION OF AN ISLAND RESULTING FROM
THE PROPOSED SALT LAKE ANNEXATION BY SALT LAKE CITY

WHEREAS, Salt Lake City was served with a notice of intent to file a petition to annex what the petition sponsor terms the Salt Lake Annexation, as shown on the map attached as Exhibit A, which could lead to a portion of what is currently unincorporated Salt Lake County being annexed into Salt

Lake City; and

WHEREAS, the proposed annexation is being pursued under and controlled by Utah State Code Sections 10-2-401, *et seq.*; and

WHEREAS, the proposed annexation would, in the opinion of the Salt Lake County Surveyor and the Salt Lake County District Attorney's Office, create an unincorporated island; and

WHEREAS, pursuant to Utah Code Section 10-2-402(1)(b)(iii)(B), if a proposed annexation will create an unincorporated island the County and annexing municipality must agree to such annexation;

NOW THEREFORE, BE IT RESOLVED, THAT;

Salt Lake County agrees to allow Salt Lake City to create the unincorporated island described in Exhibit A that would result if Salt Lake City accepts, certifies, and approves, the proposed Salt Lake annexation and its otherwise able to meet the requirements of Utah Code Sections 10-2-401, *et seq.*

It is the hope of Salt Lake County that Salt Lake City will use its best efforts to also annex the unincorporated island that would be created by the proposed Salt Lake Annexation.
