We respectfully request that you refund 2019 personal property taxes to the taxpayers listed on the attached printout. Each of these taxpayers has applied for a small business personal property exemption, and also paid the calculated personal property tax - which resulted in a credit on our records.

The requirement for personal property small business exemption is that taxpayers have a total taxable value within Salt Lake County of less than \$10,800. Our office has reviewed each of these accounts and determined that they qualify for the exemption.

The total amount of this refund is \$2,012.07 that was calculated on a total taxable value of \$252,297.
