Please accept this request of the following reappointments to the Salt Lake County (SLCo) Zoo, Arts & Parks program (ZAP) Tier I + Zoological volunteer Advisory Board. The reappointments of the ZAP Advisory Board members reflect the recruitment priorities of the Mayor's Office to increase the diversity of backgrounds and perspectives of the board, abides by the operational guidelines of the Tier I + Zoological volunteer Advisory Board and to the extent practical, is evenly divided by county council. If approved, these reappointments would provide continuity of the completion for our seven-member board makeup.

Bill Applegarth – District 5 Victoria Panella Bourns – District 1 Noemi Hernandez-Balcazar – District 2

Reappointment of Bill Applegarth (District 5) current vice chair, would be for another three-year term on the Tier I + Zoological volunteer Advisory Board. Mr. Applegarth was with LDS Church Educational System for forty years as teacher, principal, area director, institute director and assistant administrator with a United States, and international assignment. Most recently he was with Riverton City as a Council member for four years, and mayor for Twelve years. Mr. Applegarth completed his first term on December 31, 2022. His second term would begin February 21, 2023, and end December 31, 2025.

Reappointment of Victoria Panella Bourns (District 1) immediate past chair, would be for another three-year term on the Tier I + Zoological volunteer Advisory Board. Ms. Bourns was with Salt Lake County from 1996-2017 as community arts specialist and ZAP program director and is currently the director of the State of Utah's Division of Arts & Museums. Ms. Bourns completed her first term on December 31, 2022. Her second term would begin February 21, 2023, and end December 31, 2025.

Reappointment of Noemi Hernandez-Balcazar (District 2), would be for another three-year term on the Tier I + Zoological volunteer Advisory Board. Ms. Hernandez-Balcazar is Granite School District's district fine arts and dance coordinator and in 2021 received the Beverly Taylor Sorenson Arts Administration Award and also recognized as contributor of the year by Utah Arts Educators Association. Ms. Hernandez-Balcazar completed her first term on December 31, 2022. Her second term would begin February 21, 2023, and end December 31, 2024.
