Invocation - Reading or Thought - Pledge of Allegiance

Ms. Catalina Davison, Secretary, Council Office, led the Pledge of Allegiance to the Flag of the United States of America.

2. PUBLIC COMMENT

Ms. Susan Sandack thanked the Council for the financial support it has offered to the Sundance Institute over the years. These contributions have made the festival affordable for people in the community. She suspected the Sundance Film Festival left Utah due to the State Legislature's unwelcoming positions on diversity, equity, and inclusion issues. However, she still felt the Council should be gracious and keep its funding promise of \$150,000 for 2025.

Council Member Winder Newton stated, for the record, that the Sundance Film Festival left Utah for financial reasons.

3. REPORT OF ELECTED OFFICIALS:**3.1. County Council Members**

Council Member Winder Newton stated she enjoyed attending the opening of the Kem and Carolyn Gardner Mental Health Crisis Care Center last week. This facility will be beneficial to the public, and will help divert people in crisis from emergency rooms or the County Jail.

Council Member Theodore stated she also enjoyed attending the opening of the Kem and Carolyn Gardner Mental Health Crisis Care Center. She encouraged

members of the community to utilize the services provided.

Council Member Theodore read a statement regarding Senate Bill 197, which was recently vetoed by Governor Spencer Cox.

I am grateful to Governor Cox for vetoing SB 197, the property tax amendments bill. This bill could have cut off our senior population from essential tax relief. I appreciate him listening to the Council's concerns, and his recommendation to visit these tax reforms as part of a comprehensive and coordinated review of Utah's tax system.

Council Member Stewart stated he was also glad that Governor Cox vetoed the bill.

Council Member Harrison stated she was glad the bill was vetoed because now vulnerable seniors will continue to receive help to stay housed.

Council Member Stringham stated what made the Kem and Carolyn Gardner Mental Health Crisis Care Center great was that anyone in crisis could simply show up and receive help. She would like the County to do more to spread the word that this resource exists. The day before the center opened, she attended a funeral of a close friend who died of suicide, which is a huge issue in the community.

Council Member Stringham congratulated Catalina Davison for becoming a U.S. citizen.

3.2. County Mayor

Mayor Jennifer Wilson delivered her weekly update.

- While there have been challenges with the Federal Government, Mayor Wilson did receive word that the Housing and Urban Development (HUD) Continuum of Care contracts discussed at a previous meeting have been signed.
- Funding for fourteen Salt Lake County Health Department positions was discontinued unexpectedly last week. These were temporary positions that were supposed to run until June 2026. The department is currently regrouping.
- The Featherstone Boarding Home, which provides deeply affordable housing

and mental health services, celebrated its grand opening last week.

- Salt Lake City will be moving forward in its upcoming meeting to create a Public Infrastructure District (PID). After that, it will apply for a Convention Center Revitalization Zone (CCRZ).

Mayor Wilson delivered a satirical April Fool's Day presentation.

3.3. Other Elected County Officials

Sheriff Rosie Rivera stated Riverton City recognized the Sheriff's Office's Major Investigations Unit, on March 18th, 2025, for its role in solving a homicide that occurred in Riverton City in August 2024. This unit consists of five detectives and one sergeant. It is available to help agencies that lack sufficient resources for solving major cases.

Sheriff Rivera met, last week, with the Auditor General and four others who will be auditing the Salt Lake County Jail. It will be a broad audit, and everything will be looked at. Specifically, the auditors will investigate the connection between the Salt Lake County Jail, the District Attorney's Office, the Salt Lake City Police Department, the courts, and any other players in the criminal justice system.

Chief Matthew Dumont delivered a PowerPoint presentation entitled Salt Lake County Sheriff's Office Funding Request to Open Oxbow Jail's Third Pod April 1, 2025. He reviewed the reason why the third pod was being opened; what it will take to open the pod; a cost breakdown; the opening timeline; and an update on the state hospital contract. Chief Dumont noted the County population has increased by 300,000 residents since new jail beds were added.

Council Member Winder Newton stated implementing the "fifth fifth" to create more jail beds was only a short-term solution. It is inefficient to transport laundry and food back and forth between the two jails. The Metro Jail must be expanded. She did not want to go against the will of the voters, but she was willing to put this issue back on the ballot in another two years.

Sheriff Rosie Rivera stated population growth, along with crime enhancements that were implemented during the last legislative session, will result in a greater need for more jail beds. This one pod will not be enough.

Council Member Stewart stated he believed the jail bond ballot initiative failed because too much was put into it.

Mayor Jennifer Wilson stated the County has been working on investments that go beyond merely creating more jail beds. These investments include affordable housing and mental health services. She emphasized the need for systemic reform.

Council Member Bradshaw asked if under-expend from the completed canal rehabilitation project was being used for this purchase.

Mr. Kade Moncur, Director, Engineering and Flood Control Division, stated the canal rehabilitation project was ongoing. It requires the division to remove and maintain vegetation on 18 miles of levee. These remote control operated robotic mowers would be very helpful in removing weeds that can grow to be eight feet tall. The work to keep the weeds under control is intensive and constant, and purchasing the mowers would free up heavy equipment operators for tasks that require a higher level of skill. While the mowers would be used primarily for the canal rehabilitation project, the division will be able to use them for other facilities as well. The funds need to be moved from the project budget to the equipment budget.

Council Member Winder Newton asked how much the mowers cost.

Mr. Moncur stated they cost around \$60,000 each.

This decision was not meant to be punitive in any way; it had already been previously determined.

Council Member Harrison stated the Council just went through a very tight budget year, and it is important to her to invest in organizations that have a long-term commitment to the County. This was about fiscal responsibility. She noted this contribution was separate from the \$130,000 of ZAP funding that the Sundance Film Festival received.

Council Member Pinkney stated she was not present during the budget discussion, so she would likely vote “nay” to rescinding the contribution.

Mayor Jennifer Wilson stated that from a personal perspective, and as a former Sundance employee, this was a sad moment for her. A lot of Utah’s recognition as a state has come through the Sundance brand. As a mayor, she assured everyone that the County will backfill the economic impact of this, just as it did when Outdoor Retailer left Utah. The nature of independent film has changed greatly and there is simply less locally created talent to be acquired. Still, she believed in the art of story-telling, and there are still many opportunities to be had.

ORDINANCE NO. 1935

ESTABLISHING THE DATE ON WHICH THE JUNETEENTH
INDEPENDENCE DAY HOLIDAY IS OBSERVED

AN ORDINANCE OF THE LEGISLATIVE BODY OF SALT LAKE COUNTY, UTAH, AMENDING SECTION 1.06.020 OF THE SALT LAKE COUNTY CODE OF ORDINANCES, 2001, ENTITLED "HOLIDAYS" ESTABLISHING THE DATE ON WHICH THE

JUNETEENTH INDEPENDENCE DAY HOLIDAY IS OBSERVED

The County Legislative Body of Salt Lake County ordains as follows:

SECTION I. The amendments made herein are designated by underlining the new substituted words. Words being deleted are designated by brackets and strike-through.

SECTION II. Section 1.06.020, of the Salt Lake County Code of Ordinances, 2001 is hereby amended to read as follows:

1.06.020 - Holidays.

A. The following days are legal holidays during which County offices are closed:

The First Day of January	New Year's Day
The Third Monday of January	Martin Luther King Day
The Third Monday of February	President's Day
The Last Monday in May	Memorial Day
The Nineteenth Day of June	Juneteenth Independence Day
The Fourth Day of July	Independence Day
The Twenty-fourth Day of July	Pioneer Day
The First Monday of September	Labor Day
The Eleventh Day of November	Veteran's Day
The Fourth Thursday of November	Thanksgiving
The Fourth Friday of November	Day After Thanksgiving
The Twenty-fifth Day of December	Christmas Day

B. In the event that a holiday falls on a Saturday, it shall be observed on the preceding Friday. In the event that a holiday falls on a Sunday, it shall be observed on the following Monday. ~~[If June 19 is on a Tuesday, Wednesday, Thursday, or Friday, the Juneteenth Independence Day holiday shall be observed on the immediately preceding Monday. If June 19 is on a Saturday or Sunday, the Juneteenth Independence Day holiday shall be observed on the immediately following Monday.]~~

C. Where public business requires, some County offices may be required to remain open for business on legal holidays.

SECTION III. This ordinance shall become effective fifteen (15) days after its passage and upon at least one publication in a newspaper published and having general circulation in Salt Lake County.
