NEW TAX DEFERRAL APPLICATION — MAY 2019 TAX SALE Kelly, Susan, Parcel # (24) 15-27-327-033, Category 202

(Recommend Approve Abatement and Hardship Deferral, effective 03/01/2019)

## Council Members:

The Property Tax Committee, at a meeting on May 16, 2019, considered an application for acceptance into the tax deferral program. The total delinquency of \$2,728.73 as of 3/1/2019 includes real property tax delinquencies plus penalties, interest, and administrative fee. A payment of \$1,477.00 has been deposited with the Salt Lake County Treasurer and credited to prepayments.

The Committee recommends hardship abatement of \$1,001.98 and that the delinquent balance be deferred under Utah Code Section 59-2-1347 subject to the following conditions:

1. \$1,476.75 from prepayments applied to pay off the delinquency.

With the deferral approved, the County Treasurer may remove the Tax Sale Administrative fee of \$250.00, apply funds from prepayments to pay off the delinquency, and the County Auditor may withdraw the property from the May 2019 Tax Sale.
