Before my work in libraries, I worked as an Activities Director and Activities Assistant for continuing care and retirement facilities. I planned senior programming around my residents' lifestyles, interests, and goals. I brought my background in aging and senior services to my library occupation and my work has always centered on including our aging residents and patrons in the library service and programming conversations.
