# Please tell us about yourself.

I grew up in Banning, California, which is between San Bernardino and Palm Springs. The population was approximately 15,000 people. It was a very diverse town. There was Hispanic and Black populations, and a Native American reservation in the area. I had an opportunity to make friends in many of those different groups. My parents were divorced when I was 14 years old. I saw my dad four times over the next four years, so I had to learn how to take care of myself. I learned to not be afraid to try different things and to learn from my mistakes. After graduating from high school, I moved to Salt Lake City and attended the University of Utah. I went on a mission for the LDS church to England for two years. I met a wonderful young woman whom I married, and we're still together 48 years later. I attended Case Western Reserve University dental school in Cleveland, Ohio. Of course, Cleveland's population is very diverse. I had the opportunity to interact with many people of different races and cultures. I spent a year in a hospital-based general practice dental residency in Youngstown, Ohio. We moved back to Utah in 1983 and started to practice in Huntsville, Utah. In 1986, I purchased a practice from Dr. Richard Duffin in Salt Lake in the Sugarhouse area. I started teaching the Predental program at the University of Utah in 1987. I have devoted my time, energy, and money to various organizations throughout my career.(see Curriculum Vitae). We are the parents of five children, two of whom became dentists - one took over my Sugarhouse practice and one who practices in Alaska. We also have 13 grandchildren ranging in age from 4 to 21. I was involved in the Boy Scouts of America in different positions for approximately 25 years. I have written four short books for youth, two of which are illustrated. For many years, I worked with predental students, and we visited a Title I school and did dental presentations for second and fourth graders.
