ORGANIZATION OVERVIEW:

The Nomad Alliance is a group of concerned citizens working together with private and public partners to end homelessness and proffer hope, by providing warmth, nourishment, shelter, transportation, employment, healing, legal and other aid, connection, and advocacy to the chronically unsheltered (nomad) population.

We are a one-stop mobile resource and advocacy group for the chronically unsheltered in Salt Lake County. Recognized with a Hellraiser Award from Crossroads Urban Center for excellent advocacy on behalf of low-income populations, our unprecedented effort to inspire and transport those on the streets to speak to those in power, has changed policy at the state and local levels! Sanctioned campgrounds, Code Blue, and most recently, a \$500,000 Salt Lake City Council appropriation for hygiene solutions like bathrooms, was inspired by nomad voices. Additionally, we have created one of the first mobile shelters in the country. Our Blue Bus runs during the coldest part of winter, now entering its third season. Our monthly massive supply drives offer everything from clothing, blankets, hygiene items, and hot, home-cooked meals to haircuts, hot showers, benefits enrollment, and legal aid. While a DJ plays and people dance. Our free ID vouchers and mass DMV appointments obtain necessary identification so people can get jobs, stimulus checks, or apply for housing and benefits. Our micro-home initiative, currently suspended until zoning laws change, showed Salt Lake City that housing people can be easier, less expensive and more successful than anyone thought. Our Sexy Nomad Calendar gifts nomads the chance to be seen, while earning stipends. And our ability to pivot to the needs of the individual has fostered dogs and puppies or stored bicycle parts for entrepreneurs so people have one less thing to stress about while getting on their feet. We found housing in days for an unsheltered woman and her newborn child and obtained donations of all the baby's needs. We've been character witnesses that freed our nomads from prison that day. We gifted 3,000 meals from Waste Less Solutions in one afternoon. We inspired a music tour to gift all its leftover catering in five US cities and counting! And so much more!

INTENDED USE OF CONTRIBUTION:

At this time, we don't have any paid staff, everyone who works with us is a volunteer. All contributions are going to directly benefit the chronically homeless population.

HOW WILL THE CONTRIBUTION PROMOTE SAFETY, HEALTH, PROSPERITY etc...

We work directly with the homeless population on the streets. We provide them with necessities for survival, pay fees for vital documents, bus passes, ID vouchers, transportation to places for assistance, eye glasses, food and clothing. We try to meet them where they are, and provide them with whatever we can, to assist them with changing their situation so they are able to get into a better situation, able to seek employment and find housing.
