- C. The County has identified another potential site and has negotiated a Real Estate Purchase Contract with the seller that would allow the property to be acquired if it is selected.
- D. The terms and conditions for the acquisition of this site are contained in a Real Estate Purchase Contract attached hereto as Exhibit A.
- E. It has been determined that the best interests of the County and the general public will be served by executing the attached Real Estate Purchase Contract. The execution of the Real Estate Purchase Contract will be in compliance with all applicable state statutes and county ordinances.
