Patricia A. Richards currently serves as Chair of the League of American Orchestras Board of Directors in New York and has served as a panelist at several national conferences. In 2007 The Salt Lake Tribune named her #1 of "Utah's Top 25 Cultural Power Brokers", praising her leadership of Utah Symphony | Utah Opera. In 2013 she received the National Opera Trustee Recognition Award from Opera America and the Governor's Leadership in the Arts Award from the State of Utah. She received the Governor's Lifetime Achievement Award at Utah

Philanthropy Day 2014.

In 2015-2016, Ms. Richards served as Interim President and CEO of Utah Symphony| Utah Opera during the Symphony's 75th Anniversary Season and while the organization conducted an international executive search. She joined Utah Opera's Board of Trustees in 1994. After the historic merger with the Utah Symphony in 2002, she was appointed Vice Chair in 2004 and served as Chair of the Board of Trustees from 2005 to 2014. She is a member of the organization's Abravanel and Peterson Societies, Maestro Club and a past performer with Utah Symphony Chorus.

Ms. Richards retired in 2009 as Senior Vice President and Senior Regional Manager for The Wealth Management Group of Wells Fargo. Following a management training position with First National Bank of Chicago, Pat began working for First Security Bank of Utah. At First Security she served in various management capacities, heading up trust and private banking and later as President of Business Financial Services for the six-state region. Following the merger with Wells Fargo she became National Director of Endowment and Foundation Markets, moving in 2003 to Wealth Management.

Her additional community service has included Chair of the Board of Governors of the Salt Lake Chamber of Commerce, Chair of the Board of United Way of Salt Lake, President of the Salt Lake Rotary Foundation, National Advisory Board of the David Eccles School of Business, Westminster College Board of Trustees, and Governor's Economic Council.

Ms. Richards holds a B.A. in Economics from Northwestern University and did graduate work in Business Administration at Northwestern University and the University of Utah. She completed National Graduate Trust School and has attended Pacific Coast Banking School. She is a Certified Trust and Financial Advisor and holds various securities licenses. She received the Athena Award from the Salt Lake Chamber in 2000 and The Distinguished Banker Award from The Utah Bankers Association in 2007.
