

OBJECTIVE: To tackle the stigma associated with mental illness with thought-provoking films, post-screening discussion panels and unique programming.

KEY MENTAL HEALTH PARTNERS: Alliance House, Disability Law Center, Intermountain Healthcare Behavioural Health, Salt Lake County, National Alliance on Mental Illness (NAMI), Polizzi, Clinic, University of Utah Neuropsychiatric Institute (UNI), University of Utah School of Medicine Department of Psychiatry, Utah Parent Center, Utah Support Advocates for Recovery Awareness (USARA), Valley Behavioural Health.

BACKGROUND: In a culture that stigmatizes people living with mental illness, LABELED Mental Health Film Festival challenges audiences to understand the person behind the labels. Stereotypically, movies portray those with mental illness as outcasts, debilitated, isolated, dependent, dangerous, unpredictable, comedic, annoying and incompetent. LABELED strives for the opposite.

Severe Persistent Mental Illness (SPMI) plagues 97,000 Utahns annually. Discussion about SPMI is often a taboo-topic for family, friends, co-workers and neighbors to address. Carefully selected LABELED films reflect the realities of stigmatization – feelings of being afraid, ignored, devalued, rejected or irrelevant. But films also emphasize that mental illness is:

- not a fault,
- not a weakness.
- not a lack of character,
- not hopeless
 - ...it is an illness.

You'll see stories of humanity through profound documentaries, film shorts, animations and full-length features. Also engage in 20-minute, post-screening discussion panels with selected filmmakers, mental health professionals, or those living with SPMI. The community conversation continues after the panel at a special dessert social, alongside an eclectic art exhibit.

The battles and struggles caused by mental illness are real, and its impact felt by many. Help tackle the stigma of mental illness, which is often worse than the illness itself. This is a unique film festival. Expect to leave inspired and engaged, as your empathy and understanding for those impacted by SPMI, and their loved-ones, is cultivated.

LABELED IS UNIQUE BECAUSE WE:

- Purposely seek out innovative, thought-provoking films from around the world which explore multiple mental-health issues from numerous viewpoints,
- Feature post-screening panels with audience, movie directors, producers, receivers of mental health services and mental health professionals,
- Enlighten the audience perceptions of mental illness through participation and discussion
- Enliven empathy and understanding for those impacted by mental illness.

THURSDAY, March 23 - Opening Night

SPECIAL Outreach to Public Policy Leaders and Students

Engaging and interactive *Art with Impact* films that build awareness about mental illness. Guests will screen and have opportunities to discuss short films that offer unique perspectives about mental illness. Films will be screened on the walls of the beautiful Canyon Terrace at the Natural History Museum of Utah. Guests will be provided a Bluetooth-headphone that gives them access to 3 "film channels." They then get to choose the films they want to see. The best part is they don't have to worry about "shhhhes" like at a typical theater. The headphones allow guests the chance to talk about their experience with peers, participating community partners, and those living with mental illness during round-table discussions.

Two full-feature films with director panelists, addressing homelessness and mental illness, will also be available to screen in the building's forum area during the opening night.





NOT CRIMINALLY RESPONSIBLE (6:00PM)





This documentary about violence, mental illness, and the rights of victims tells the story of a troubled young man who stabbed a complete stranger 6 times in a crowded shopping mall while gripped by psychosis. Twelve years later, his victim,

who miraculously survived, is terrified to learn that he's out, living in the community under supervision. He's applying for an absolute discharge, and if he succeeds, he'll no longer be required to take the anti-psychotic drugs that control his mental illness. With unprecedented access to the patient, the victim, and the mental institution, the film looks at both sides of the debate and puts a human face on the complex ethical issues raised.
