## **Establishing Rates for Exhibit Software Leasing (New Product)**

#### **Exhibit Software Leasing**

Our Digital Interactive Science Exhibits are designed and manufactured by Clark Planetarium staff to enhance our visitors' experience. These exhibits are also marketable software products that numerous planetariums have expressed interest in purchasing. Rates and discounts are based on a Punt Consulting Group market study of potential buyers among planetariums and science centers. We propose three tiers of pricing to reflect the complexity and scale of the various exhibits.

### **Establishing Rates for Content Leasing and Clips (New Product)**

#### **Content Streaming - New Product**

Planetarium dome theatre programs streaming over the Internet is an emerging delivery method. For a low short-term usage fee we will offer online access to our content, similar to Amazon and iTunes video delivery. We are aware of three other vendors of streaming content in the planetarium field. Our proposed rates are competitive with these vendors, and should be attractive to small school district and college planetariums with limited budgets who want to use our programs for short periods of time.

### **Additional Discounts for Content Leasing**

A 10% discount for each qualifying criteria:

- Operated by a school district or a school (K-University)
- Does not charge admission for any planetarium show

A \$100.00 discount per order is offered to licensees that agree to forego delivery of physical media and take delivery of the show via FTP, Dropbox, or other electronic means.



## **Rate Increase for Membership**

A recent Utah State Tax Commission audit concluded that we should charge sales tax on our memberships. We propose an increase in our membership rates to cover the sales tax as well as a small increase. Rounding up to the nearest five dollars provides us a small increase in revenue and is in line with rates of similar institutions. Our last rate increase was in 2009.
