PASTOR FRANCE A. DAVIS UNIVERSITY OF UTAH SCHOLARSHIP FUND ANNOUNCED

COMMUNITY AND THE UNIVERSITY OF UTAH JOIN TO CREATE NEW SCHOLARSHIPS

Jan. 17, 2008 – A group of influential Utah community leaders is joining with the University of Utah to create the Pastor France A. Davis University of Utah Scholarship Fund. The new scholarship fund, named in honor of one of the state's most prominent leaders, will work to advance educational opportunities for meritorious, financially deserving university students, particularly those of African American descent.

In establishing the scholarship community leaders note that African American students at the University of Utah represent less than one percent of the student population. They cite financial limitations as one of the greatest barriers facing black students, not only in enrolling in higher education, but also in remaining in college to earn a degree. "Our university is fortunate to have such committed community partners invested in the success of students," says David Pershing, senior vice president for academic affairs at the University of Utah. "The Pastor France Davis Scholarship Fund will provide African American students with important financial assistance, mentoring, and academic support as they complete their education." Pershing adds, "We are thrilled that community leaders have named their scholarship fund after Pastor Davis because he has been such a strong force for good in the community and is so integral to the fabric of the University of Utah."

Kathleen Christy, assistant superintendent, Salt Lake City School District, and a member of the scholarship committee, echoes Pershing's sentiments, "Pastor France A. Davis has been a religious leader, educator, community activist and bridge builder in Utah for more than three decades. His personal educational accomplishments, in addition to his commitment to improving educational opportunities for disadvantaged students, make him the ideal person in whose honor the scholarship should be named."

Community members are being asked to consider making a contribution to this historic effort, the first scholarship fund established at the University of Utah with the sole intent of raising funds for scholarships specifically to assist traditionally marginalized African American students. While tuition at the University of Utah is relatively modest by national standards—\$5,000 a year for Utah residents—it is still beyond the reach of many local citizens of color. Organizers feel that the success of this new scholarship fund is in the strength of the community-University of Utah partnership.

Octavio Villalpando, associate vice president for diversity at the University of Utah, states, "Community leaders who came together to establish this private scholarship fund are to be commended for helping us enhance the success of African American students at the U. We also acknowledge their foresight for naming it in honor of Pastor Davis, a respected leader who has made invaluable contributions to the lives of many citizens in the state of Utah. The university

greatly appreciates the contributions that the Pastor France Davis Scholarship Fund will make to further the success of African American students.

Pastor France A. Davis leads the Calvary Baptist Church in Salt Lake City. Raised in Georgia, he has lived in Utah for thirty-three years. As a young college student he met and marched with the Rev. Martin Luther King, Jr. Davis went on to serve in the U.S. Air Force and earn five college degrees. He teaches at the University of Utah, and contributes his time and energy to numerous civic, business, educational, and charitable organizations to further the cause of social justice.



Mr. Darnel Haney

Darnel Haney was born in Phoenix, Arizona, in 1937, in 1953 he was one of 25 black students who were integrated into inner city Phoenix Union High School with a student body of six thousand. He played in the All-State Basketball Cournament his junior and senior years. The team took the state championship title both years.

Darnel graduated from Utah State University and then went on to earn a Master's Degree from Utah State Stocking. Death whiteld for the blo Corps Program as a courselot, Weber State College as Associate Dean of Students, and Lorain Gomy Community College in Epris. Otho, as Director of Student Activities, where he also taught sociology. Demed taught cultural diversity to teachers, police, highway aborol, and the forest service throughout. Utah and other western states.

Darnel has served on the State Board of Aging Urah State Arts Council the Northern Urah Boy Scourcil Land and the Governor's Stack devisory Committee. He is currently chairperson of the Sheriff's Citizens Review Committee of Weber County and remains on the Weber County Board of Aging. Darnel was a volunteer for the 2002 Stal Lake City Winter Olympics. He is currently a volunteer for Peery's Egypta'n Thearts. Sundance Film Petsival, and the GOAL Foundation.

After retirement Darnel became a folk artist painting and sculpting African-American art themed "from Africa to Black America"

Darnel and Marie have been married for 53 years. They have three children, four grandchildren and four great grandchildren.

Mr. Huntsman earned his undergraduate degree at The Whatron School of Business at the University of Fennsylvania and an MBA from the University of Southern California, Mr. Huntsman was a U.S. Akval Gunnery Officer. He served under President Richard M. Nixon as Special Assistant to the President and as White House Staff Secretary. He has been awarded thirteen honorary doctorate degrees.

Forty years ago, Mr. Huntsman the Founder and Executive Chairman of Huntsman Corporation, began a small eutrepreneural plastict packaging business. Originally known for ploneering minoutions in packaging and, later, for rapid and integrated growth in petrochemicals, its operating companies today manufacture chemical products used in a wide range of industriet, with more than 16,000 employees and multiple locations woldwide. The Company's 2015 revenues exceeded \$15 Billion.

Mr. Huntsman and his wife, Karen, founded the Huntsman Cancer Institute (HCI) in 1995 and acclerate the work of Curing cancer through human genetics. Mr. Huntsman's early contributions to Huntsman Cancer Institute amounted to \$225 million. The Institute is now one of Americas major cancer centers declicated to finding a cure. The recently announced \$100 million expansion will double the laboratory space and create the Primary Children's and Families' Cancer Research Center, which will focus exclusively on inherited and childrhood cancers. Today, approximately \$15 billion has been directed to the billianty of HCI, almost half of which was domated by the Huntsman family. The Chronicle of Phillianthopy placed Mr. Huntsman second on their 2007 list of largest donors. In 2011, Forbes Magazine counted him among the 18 'most generous givers on the planet."

Mr. Huntsman has served in senior leadership positions in The Church of Jesus Christ of Loureday Sains for the post fifty years. His latest assignment was service as a member of the Sevenies Quotum.

Mrs. Karen Haight Huntsman

Karen Haight Huntsman is a woman of considerable accomplishment and deep commitment to her family, faith, and community service. She is married to industrialist, Jon M. Huntsman, and was her husband's greatest source of support as together they founded Huntsman corporation, forbes magazine, in 1989, after six weeks of extensive research, referred to Karen Huntsman as one of the outstanding women in America and gave her the title of Cafman of the Chairman because of her significant influence and remarkable impact on the operations of the company and because of her high sense of service to chairly and humanitarial causes.

Mrs. Huntsman's honors, awards, and accolades have been many, but certainly none more than being mother of 9 children, gandmother of 56 and great-grandmother of 17. She is the daughter of the late Ruby Haight and Elder David B. Haight of the LDS Quorum of the Twelve Appatles.

Although central to her life, family is not the only organization that benefits from her giving spirit. The broader community has benefited enormously too. Her humanitarian endeavors have been evident through the cention of the Huntsman Cancer Institute and Hospital at the University of Utah which today is setting new standards for basic molecular research, along with clinical application and treatment.

Karen Huntsman's active Interest in community affairs is reflected in her long-standing service on several boards of directors, including the Utah State Board of Regents, the University of Utah's National Advisory Council, Primary Children's Medical Center, and the First Security Corporation.
