Council Members:

A recent decision of the Utah State Tax Commission orders Salt Lake County to adjust the 2016 Market Value on the above property from \$2,195,200 to \$1,810,000. This changes the 2016 property taxes from \$32,594.33 to \$26,874.88. The taxpayer has paid \$32,594.33 which results in an overpayment of \$5,719.45.

Based on the order of the State Tax Commission, we recommend that the Council authorize the County Treasurer to refund to the recorded owner at the time the refund is issued the 2016 taxes in the amount of \$5,719.45 and interest, if applicable, to be calculated by the County Treasurer at the appropriate rate as provided by State Statute and to release any or all BOE refunds.
