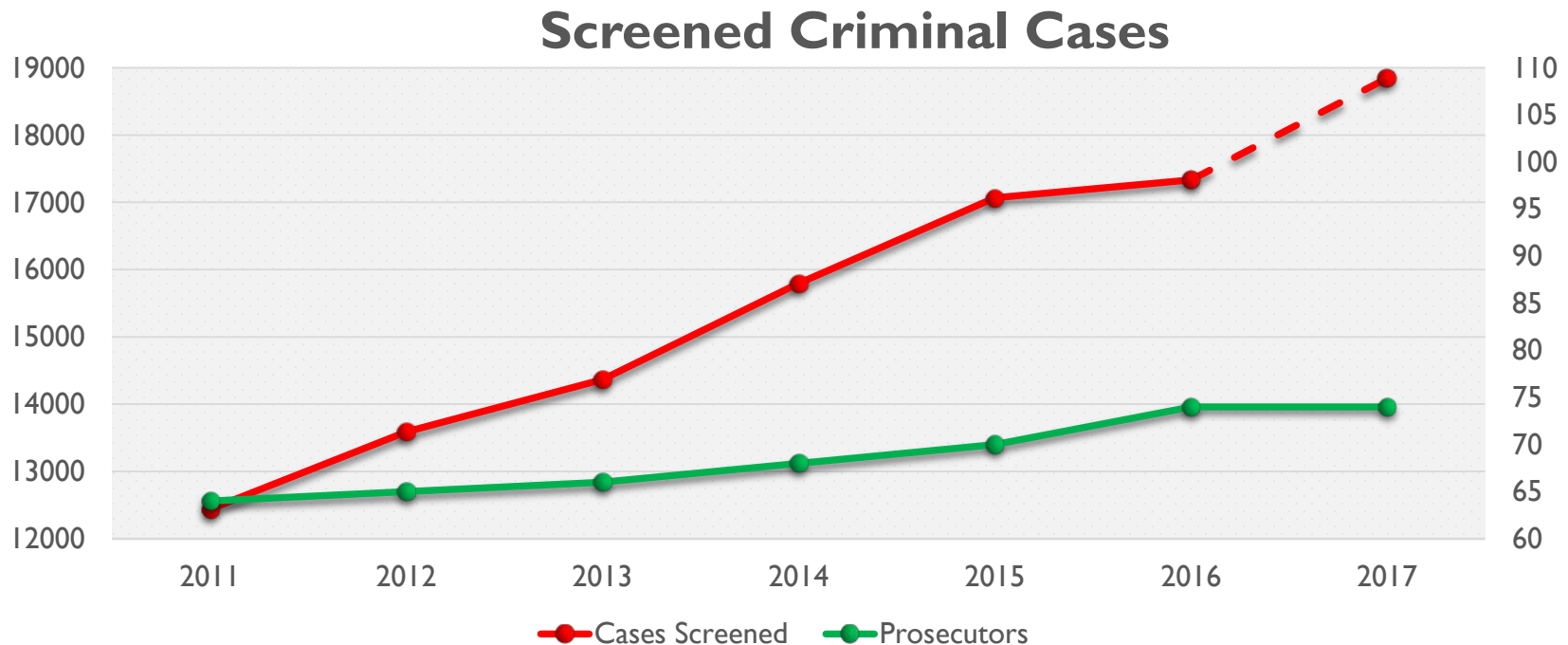

What We Do – Criminal Division

Screening of Adult Criminal Cases

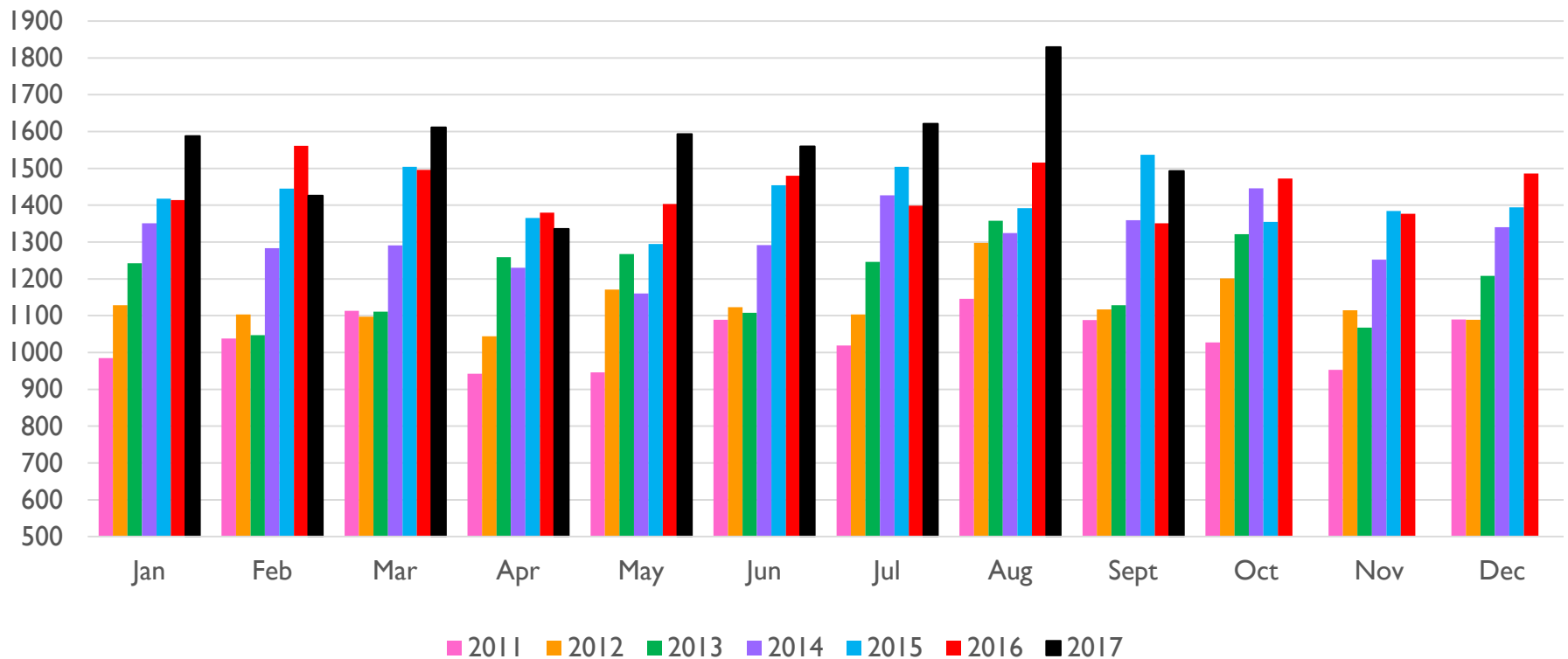
- ▶ In 2011, the District Attorney's Office screened 12,436 cases for criminal charges.
- ▶ In 2017, the District Attorney's Office is on track to screen 18,846 cases for criminal charges.
- ▶ ***The District Attorney's Office is handling an additional 6,410 adult cases with only 10 more prosecutors than 2011.***



Continued Increase in Adult Criminal Cases Submitted for Screening

- ▶ For six of the nine months recorded thus far in 2017, the District Attorney's Office has received more cases for that month than ever previously recorded.

Screened Criminal Cases

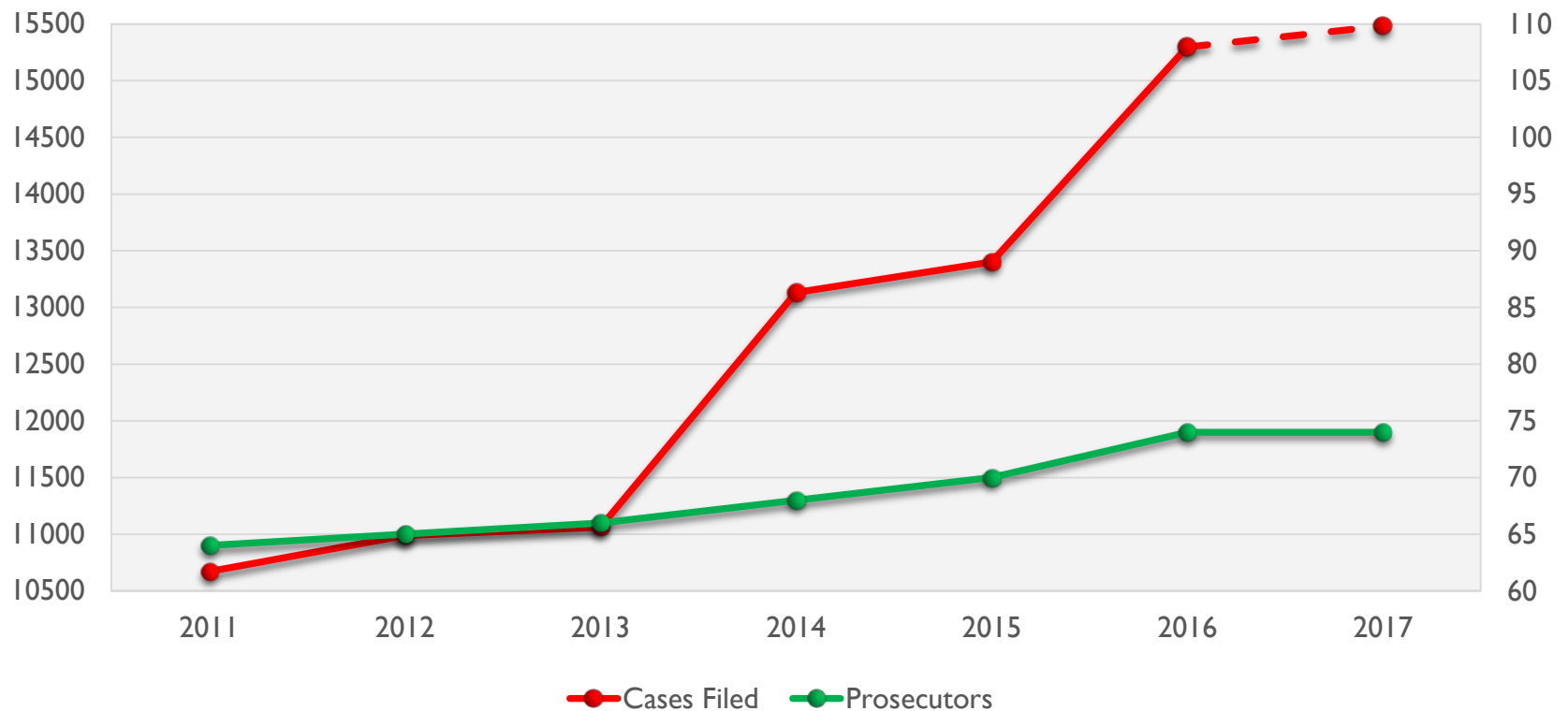
