### **Description and Justification:**

STR 2017 True - Up & Pay for Success: This adjustment represents a 2017 budget restructuring designed to enable an on-going source of General Fund dollars for 2018. The funds will be used to assist in the opening of Oxbow Jail. Absent the adjustment, the dollars would otherwise be available in 2019.

The adjustment has three parts: 1) transfers funds from Visitor and Promotion to the General Fund to reduce its funding for Parks and Recreation; 2) reduces an appropriation for debt service for an estimated bond payment (we issued the debt later than expected, thus lowering the payment for 2017); and 3) increases the appropriation for Pay for Success program by \$5.5 million. This completes the county obligation for this program and fully funds the escrow held by the County for that purpose.

The end result is freeing up an on-going revenue source to be utilized for Oxbow Jail.
