



Salt Lake County Board of Health name recommendation for new health department building

During the regularly scheduled and noticed Salt Lake County Board of Health meeting held October 5, 2017, the Board considered the following as potential names for the health department building currently under construction in Salt Lake City.

- **Salt Lake Public Health Center:** This name focuses on the clinic being located in Salt Lake City.
- **Downtown Public Health Center:** This name focuses on this clinic's location as being centralized in Salt Lake City.
- **Dr. Harry Gibbons Public Health Center:** This name follows the precedent set by the Ellis Reynolds Shipp clinic by naming a health department location after an individual. Dr. Harry Gibbons was appointed health officer in June 1971 and held the position for twenty-two years, with his office located at the Salt Lake City public health center.
- **Central City Public Health Center:** This name is included to encompass both the location of the clinic, as well as the continued partnership between the health department and Community Health Centers, who will co-locate in the new facility to provide healthcare services to underserved community residents once construction is completed.

Comment was received from Health Department employees who will be working in the new building. No other comment was received.

The Board of Health's recommendation to the Salt Lake County Mayor and Salt Lake County Council is the Salt Lake Public Health Center. Exterior signage would identify the building as the Salt Lake County Health Department, Salt Lake Public Health Center.
