

Achievements

Implemented LEAN management principles to reduce expenditures while improving services. **Results:** Saved \$4.6 million and increased profit margin by 34%.

Lobbied the Utah State Legislature for additional funding to complete three essential transportation projects in West Jordan. Prepared reports and applications for Salt Lake County transportation funding and made presentations to the Public Works Subcommittee promoting West Jordan projects.

Results: Received over \$13,400,000 in supplemental funding to purchase property and build 5600 West and 4000 West, and make improvements to 7800 South in West Jordan.

Facilitated and coordinated the completion of the Jordan River Trail project.

Partnered with three other municipalities, Salt Lake County, the State Legislature, the Federal Department of Natural Resources and the Department of the Interior's Parks and Trails division to design, fund, and complete construction on a missing segment of the Jordan River Trail. The project also involved encouraging participation from the Jordan Water Conservancy District, the Jordan River Commission, public utility companies and private property owners.

Results: Secured over \$2.5 million from national, local and regional partners to complete construction and build a tunnel linking the trail. The trail is currently under construction and will be finished by September 2013.
