# Transportation Pilot Program February 27, 2018

## **Purpose**

Provide reliable transportation so clients can get to work, earn a livable wage, and become self-sufficient.

## Background

Operation Rio Grande clients who are in the drug court program, moving successfully through treatment and living in safe, affordable housing are now looking for jobs. Salt Lake County has identified a network of employers willing to hire these individuals. However, the jobs are in an area not easily accessible on public transit.

The Transportation Pilot Program will remove the transportation barrier to employment, creating an opportunity for the individuals to get to work with reliable transportation.

#### How it works

- The LDS Church is donating a van and gas for one year, to Advantage Services, a 501(c)(3)
- Salt Lake County will contribute \$19,000 to pay for a part-time driver for one year.
- Advantage Services will hire and manage the driver.
- Salt Lake County will develop a network of participating employers who are willing to hire individuals with a criminal record and pay them a livable wage.
- Salt Lake County will develop shuttle routes

#### **Benefits**

- Helps clients access better work opportunities and become self sufficient
- Helps employers find reliable, motivated, and hard-working employees who are well supported and regularly drug-tested (which will help promote safe working environments)
- Helps solve current transportation gaps in our system that limit work opportunities and inform changes that should be made to our public transportation system
- Allows clients to both work and continue their recovery, by having reliable transportation that accommodates their continuing outpatient treatment.
