

As Medical Director of youth services I led the development and implementation of a hospitalist type model for child psychiatrists providing care on the child and adolescent inpatient unit. This allowed physicians to work intensely for periods of time with breaks to allow scheduled time off and academic endeavors. This changed workflow allowed increased capacity, improved patient satisfaction and improved physician satisfaction. Still

- used today, this system additionally has been an aid in recruiting and retaining Child and Adolescent psychiatrists to work on the inpatient units.
- 2004 Attended the **Advanced Training Program in Health Care Delivery Improvement-Accelerated Version**, conducted by Brent James, MD through Intermountain Health Care
- 2005 - Present Involved in the development of a white paper on *Current and Emergind Issues in Public Substance Abuse and Mental Health* which can be viewed at http://www.dsamh.utah.gov/docs/current_emerging_issues.pdf
- 2008 **Leadership Development for Physician Executives:** This was an intensive course spread out over several weeks focusing on provideing information and skills to Physician Leaders. This course was developed and taught by faculty from the University of Utah's own David Eccles School of Business Executive Education Program.
- 2010 - Present Co-created GATE (Giving Access to Everyone) a web-based consultation system to provide rapid consultation to primary care providers for their patients with serious mental health issues. Unique features of this program include access to a web-based questionnaire filled out by the patient and/or parents in a de-identified manner. This allows a telephone consultation between the psychiatrist and primary care provider that includes input from the patient. This program was beta tested for over a year with several freestanding clinics with resultant surveys that show high patient and provider satisfaction with the program. Our webpage can be viewed at www.gateUtah.org . I believe we have developed a unique way of providing clinical service as well as a way to leverage our expertise into the primary care setting.
- 2013 First physician to participate in the Performance Excellence Facilitators training at the University of Utah. This training involved the learning of principles of quality improvement as drawn from LEAN, 6 Sigma, and other quality initiatives, and then developing our own quality improvement project. I led the development of a project looking at the length of time it took physicians to return phone calls from our central admission center in an attempt to increase the speed with which patients could successfully be admitted to our inpatient services.
