

Sorry Anna. I was assisting a friend with funeral arrangements for a good friend. Our State budget comes from the National Everytown for Gun Safety.

Moms Demand Action - Utah is a totally statewide group of volunteers. We are operating the whole state on a budget of approximately \$750. There is no paid staff and most of our funds go towards education/tabling events. I don't have a formal audit but I can give you a breakdown of how we budgeted \$500 last year and our current budget plans for this year.

2017: \$500 Budget

Renting SLC Library Auditorium for screenining film and panel discussion. \$110 May. Renting West Pavillion at Canyon Rim Park \$75 June Renting non-profit space at downtown farmers market \$100 June - Oct Purchasing canopy and sand bag holders for outdoor tabling events \$215

2018: \$750 budget plans

Food and decorations for 5 year anniversary celebration \$125 Jan
Renting non-profit space at downtown farmers market \$125 June - Oct
Renting West Pavilion and Amphitheater at Canyon Rim Park: \$150 June
New State Groups start up funds: Southern Utah (St. George), Provo Group, Logan Group, (\$100 each for tabling/education)

I hope that is helpful. We are trying to raise money on our Facebook page for this event, which would give us more funds for education/tabling of new groups.
