Get Involved With Circles

The Circle

Circles Salt Lake supports families in their journey from poverty to stability. Each Circle is comprised of a carefully matched Circle Leader (a family with low income) and Allies (resourced family or individual).

The Circle Leaders identify their personal goals and reconnect to their dreams. Through the use of SMART (specific, measurable, achievable, relevant, and time-bound) goal setting and budgeting work, they outline their plans to bring their dreams to reality.

With the committed support and friendship of their Allies and community resources (Resource Teams), they develop a realistic plan to reach them. Each week, the Circles Group meets together to discuss strategies for attaining financial stability and to develop their friendship.



Allies & Weekly Meetings

Our weekly volunteers only need to be good at being a friend. From there they are trained as Allies to support Circle Leaders in achieving their goals. Allies and Circle Leaders will meet weekly at the Circles meetings. Circle Leaders will lead the meeting by discussing progress and accomplishments made towards their goals and economic stability plans.

Children's Program

Children ages 0-17 divide into 2-3 groups to meet with other children their age and enjoy a lesson or activity together. The Children's program is staffed by volunteers who are trained and background screened. Lesson themes include goal setting, nutrition, communication, and building relationships. Children have opportunities after the lesson to engage in free-play, homework club, or structured activity.

The General Evening Schedule

5:15-5:45 Set Up for Dinner

5:45-6:30 **Dinner** provided by donors & volunteers. Circle Leaders, families, Allies, and volunteers enjoy dinner together.

6:30-6:45 Clean-up Dinner & Set Up for meeting

6:45-7:45 Adults attend their **Weekly Meeting** while children meet for their children's programming.
