#### Physician licensed in Utah:

**Stacey Bank, MD** – is the Medical Director at the University of Utah Intensive Outpatient Clinic in Salt Lake County and lives in Salt Lake City, Council District #4. Dr. Bank oversees an integrated clinic for high-risk patients with both complex medical and behavioral health needs and works closely with the population health services at the University of Utah and is passionate about identifying and treating health issues that affect specific members of the community, as well as the community at large. She has been recommended by both Karen Crompton, Human Services Director, and Deputy Mayor Erin Litvack. This appointment would be for one 3-year term from July 1, 2021 – June 30, 2024.

Kencee Graves, MD – is the Associate Chief Medical Officer and Associate Professor at the University of Utah Health in Salt Lake County and lives in Millcreek, Council District #4. Dr. Graves has work closely in the past on developing plans that will keep our community, children, and health care work force safe and healthy and has served on the Fourth Street Clinic Board since 2019. She often sees patients that don't have the ability to advocate for themselves that are diverse in age, gender, race, ethnicity, illness, and life experiences. She has been recommended by Mitchell Park, Council District Attorney. This appointment would be for one 3-year term from July 1, 2021 – June 30, 2024.

I am a physician with 20 years experience and a lifelong resident of Salt Lake County. I love spending time with my husband and our two beautiful daughters, ages 8 and 10. That all keeps me very busy, but when I have time, I love to walk my dogs, cook, knit, watch sports, and I am so excited to get back to traveling. I keep up on current events and politics, and don't mind discussing any topic with any person. I am an outspoken ally for marginalized communities and a tireless advocate for equity and inclusion. I take pride in my work and always want to be an example of integrity and compassion to my daughters.

Why are you interested in serving on a board or commission?

Spending the majority of my life in Salt Lake County, I have witnessed its growth and change, for better and worse. Being on the SL County Board of Health would be an opportunity to use the skills and knowledge I've acquired from my life's work to advocate for the health and well-being of members of my beloved community.

What education, work experience, or volunteer experience do you have that applies to the board you are applying for?

I am a primary care physician and medical director of the University of Utah Intensive Outpatient Clinic, an integrated clinic for high-risk patients with complex medical and behavioral health needs. I have experience with committee work at a high level, leading a team, and confidently making decisions that have big impact. I work closely with the Population Health service line at the U, which is a field that can identify and treat health issues that affect specific members of a community, as well as the community at large.

What unique perspectives could you bring to the board?

When I presented our clinic model to the County's CJAC last year, Mayor Wilson commented on her admiration for "meeting our patients where they are". I have adopted that phrase (always giving credit to the Mayor), because I feel it really identifies and explains what makes our clinic unique. We find a way to take the individual story of a patient and create a treatment plan that for that specific person at that moment. That way of practicing has allowed me to look widely at all situations and identify specific needs, instead of making "one size fits all" decisions. That also requires the understanding that as situations change, plans may need to change. Whether it's the way I interact with my girls, prepare food for a dinner party, or help keep a medically complex patient off the streets and out of the hospital, I use compassion and forward thinking to assess a situation and meet the needs at hand, while recognizing the need for adaptability. As a result, my unique perspective is one that includes not only "Where are we now?" but "What happened to get us here?" and "What will happen if we do or don't change course?".
