currently outstanding General Obligation Bonds, Series 2015B. These refunding bonds are Direct Placement issuance with a forward purchase agreement with JP Morgan Chase and includes prepayment of costs of issuance from the General Fund for both series estimated at \$210,000. The cost of issuance will be reimbursed to the county through bond proceeds at the issuance date. Series GO 2015B refunding will result in a net present value savings of \$662,952 or 4.80%, an average annual savings of \$66,513. Series STR 2014 refunding will result in a net present value savings of \$758,687 or 3.88%, an average annual savings of \$78,693.

The parameter resolutions for both of these bonds were approved by the County Council on January 4th, 2022.
