RE: BHSAC – Council Member Reappointment Request

The Behavioral Health Services Advisory Council (BHSAC) is seeking reappointment for current council member, Sheila Young. Sheila's second appointed term expired on April 30, 2022, and she is currently eligible for one additional 2-year term. A motion was made during the last BHSAC meeting held April 6, 2022, to submit this request to the Mayor and County Council for review and consideration for reappointment. The BHSAC members voted in unanimous support of the motion to request reappointment of Sheila Young for a final 2-year term.

Sheila Young is the Associate Vice President of Community Engagement with Molina Healthcare. Sheila is responsible for market share growth and community-based relationships as well as provider relationships. She is also a Registered Nurse (RN) and has worked directly with the behavioral health and substance use disorder (SUD) populations for many years. Sheila's experience includes having been responsible for complex care management and the restrictions program at Molina Healthcare for almost a decade. She also has personal experience working with a family member who struggles with behavioral health issues and has learned and assisted in navigating the behavioral health systems of care. When asked what unique perspectives she brings to the BHSAC, Sheila reported, "I feel that my personal experience as well as my professional experiences with people struggling with a mental health and/or SUD diagnosis has allowed me to understand the barriers, the gaps in care, and hurdles that need to be overcome to achieve positive health outcomes. I feel that my experience working on the Medicaid payer side also allows me to contribute from a different perspective." Sheila has been a great asset for the BHSAC as she is able to help bring input and insight from the perspective of the Medicaid plans that are managed through the ACOs (Molina is one of the four ACOs). This collaboration ensures consistency in the behavioral health benefit between Medicaid plans and more importantly provides Salt Lake County residents with access to the best possible services and resources, regardless of who manages their insurance plan.

a. Yes. The BHSAC members voted in unanimous support of the motion to submit this request to reappoint Sheila Young. In addition, Tim Whalen, Behavioral Health Services Division Director, has approved this reappointment request.

 - Sheila Young's <u>second</u> appointed term (2-year term) expired on April 30, 2022. She is eligible to renew <u>one</u> additional 2-year term. Maximum of <u>three</u> appointed terms, or a total of <u>six</u> years per the BHSAC Bylaws.

BHSAC Terms - A BHSAC member may not serve more than three (3) full consecutive terms, or a total of six (6) years. A 2-year initial term is standard; however, initial terms may vary to provide staggered expiration dates. Terms that expire during re-bids or other critical events shall have their terms automatically extended to the conclusion of that special event. Council members may resign at any time and vacancies may be filled for the remainder of the unexpired term by appointment of the Division/Mayor's Office through a specified selection process.

- 1-Year Term 1-year terms are not typical but done on occasion to stager term dates. After first year, council members will have the option of renewing two additional terms totaling five years (one two-year term and one three-year term). Maximum of three terms totaling six years.
- 2-Year Term After initial 2-year term, council members will have the option of renewing two additional two year terms. Maximum of three terms totaling six years.
- 3-Year Term After initial 3-year term, council members will have the option of renewing one additional three year term. Maximum of two terms totaling six years.
