RE: BHSAC – Council Member Reappointment Request

The Behavioral Health Services Advisory Council (BHSAC) is seeking reappointment for current council member, Mary Bennett. Mary's second appointed term expired on January 31, 2022, and she is currently eligible for one additional 2-year term. A motion was made during the last BHSAC meeting held April 6, 2022, to submit this request to the Mayor and County Council for review and consideration for reappointment. The BHSAC members voted in unanimous support of the motion to request reappointment of Mary Bennett with a final 2-year term.

Mary Bennett is a citizen representative on the Behavioral Health Services Advisory Council and has served in this capacity for the past four years. Mary is the parent of three children who have received behavioral health services for substance use disorders and mental health conditions. As such, Mary brings a very unique and invaluable perspective to the BHSAC as she is able to provide personal input and suggestions for improvement based on her lived experience interacting with local behavioral health providers, law enforcement, community resources and advocacy groups, etc.

Below is the required approval, diversity, and appointment information specific to this reappointment request.

1. Has this board request been approved through leadership such as Department/Division Director and/or the Board you manage?

a. Yes. The BHSAC members voted in unanimous support of the motion to submit this request to reappoint Mary Bennett. In addition, Tim Whalen, Behavioral Health Services Division Director, has approved this reappointment request.

BHSAC Terms - A BHSAC member may not serve more than three (3) full consecutive terms, or a total of six (6) years. A 2-year initial term is standard; however, initial terms may vary to provide staggered expiration dates. Terms that expire during re-bids or other critical events shall have their terms automatically extended to the conclusion of that special event. Council members may resign at any

time and vacancies may be filled for the remainder of the unexpired term by appointment of the Division/Mayor's Office through a specified selection process.

- 1-Year Term 1-year terms are not typical but done on occasion to stager term dates. After first year, council members will have the option of renewing two additional terms totaling five years (one two-year term and one three-year term). Maximum of three terms totaling six years.
- 2-Year Term After initial 2-year term, council members will have the option of renewing two additional two year terms. Maximum of three terms totaling six years.
- <u>3-Year Term</u> After initial 3-year term, council members will have the option of renewing <u>one</u> additional <u>three</u> year term. Maximum of <u>two</u> terms totaling <u>six</u> years.
