RE: BHSAC – Council Member Reappointment Request

The Behavioral Health Services Advisory Council (BHSAC) is seeking reappointment for current council member, Dr. James Ashworth. Dr. Ashworth's second appointed term expired on March 31, 2022, and he is currently eligible for one additional 2-year term. A motion was made during the last BHSAC meeting held April 6, 2022, to submit this request to the Mayor and County Council for review and consideration for reappointment. The BHSAC members voted in unanimous support of the motion to request reappointment of Dr. James Ashworth with a final 2-year term.

Dr. Ashworth is the Executive Vice Chair of the Department of Psychiatry at the University of Utah and the Medical Director of Psychiatric Services at the Huntsman Mental Health Institute (HMHI). Dr. Ashworth is a practicing psychiatrist and child psychiatrist who has worked in this community since 1999. He spent 10 years as a gubernatorial appointee to the Utah State Board of Substance Abuse and Mental Health and gained understanding about State systems treating those with behavioral health conditions during this time. Dr. Ashworth's experience and expertise in behavioral health conditions, social determines of wellness, diagnostic and best-practice treatment interventions is crucial to this council. He is able to discuss emerging trends, scientific research, empirically validated treatment interventions, and, together with the other council members, make recommendations that help ensure the overall success of the BHSAC initiatives. When asked what interests him in continuing to serve on the BHSAC, Dr. Ashworth reported, "I have always felt that helping improve the mental health of our community is part of our mission, and participation in the board helps me understand the broader issues and how we might collaborate with other entities to make improvements." Dr. Ashworth has been involved from the beginning with the Crisis Care Center development and continues to be a source of invaluable information and communication for the BHSAC.

BHSAC Terms - A BHSAC member may not serve more than three (3) full consecutive terms, or a total of six (6) years. A 2-year initial term is standard; however, initial terms may vary to provide staggered expiration dates. Terms that expire during re-bids or other critical events shall have their terms automatically extended to the conclusion of that special event. Council members may resign at any

time and vacancies may be filled for the remainder of the unexpired term by appointment of the Division/Mayor's Office through a specified selection process.

- 1-Year Term 1-year terms are not typical but done on occasion to stager term dates. After first year, council members will have the option of renewing two additional terms totaling five years (one two-year term and one three-year term). Maximum of three terms totaling six years.
- 2-Year Term After initial 2-year term, council members will have the option of renewing two additional two year terms. Maximum of three terms totaling six years.
- 3-Year Term After initial 3-year term, council members will have the option of renewing one additional three year term. Maximum of two terms totaling six years.

Co-created GATE (Giving Access to Everyone) a web-based consultation system to provide rapid consultation to primary care providers for their patients with serious mental health issues. Unique features of this program include access to a web-based questionnaire filled out by the patient and/or parents in a de-identified manner. This allows a telephone consultation between the psychiatrist and primary care provider that includes input from the patient. This program was beta tested for over a year with several freestanding clinics with resultant surveys that show high patient and provider satisfaction with the program. Our webpage can be viewed at www.gateUtah.org . I believe we have developed a unique way of providing clinical service as well as a way to leverage our expertise into the primary care setting.

As Medical Director of youth services I led the development and implementation of a hospitalist type model for child psychiatrists providing care on the child and adolescent inpatient unit. This allowed physicians to work intensely for periods of time with breaks to allow scheduled time off and academic endeavors. This changed workflow allowed increased capacity, improved patient satisfaction and improved physician satisfaction. Still used today, this system additionally has been an aid in recruiting and retaining Child and Adolescent psychiatrists to work on the inpatient units.

Quality & Value Improvement Projects

Early spring of 2019

Created and led a team to reevaluate the decision to close the 5West inpatient psychiatric unit which would have resulted in the loss of 22 inpatient psychiatric beds at the main University of Utah Hospital. Found solution of shrinking the unit to 12 beds with minimal remodeling allowing the preservation of inpatient psychiatric beds in this location to continue to serve the medically complicated psychiatric patients.

2018

Led team that redesigned the inpatient process for creating and documenting in the Master Treatment Plan for every admitted inpatient at the University of Utah Neuropsychiatric Institute. This is a CMS requirement that we were not performing correctly per an early 2018 CMS audit. This process was redesigned in a way that was approved by CMS and DNV and with enough clarity that our IT department was able to force the EPIC system to deliver the required documentation in an electronic format. This was so successful that this design was passed on to the EPIC national organization

Spring 2016

Co-Developed the Mental Health Integration program that placed 3rd yr gerneral psychaitry residents in the University of Utah Community Clinics as part of the primary care team. This program also placed MSW's on the primary care teams to allow primary care porviders to immediately hand off patients with mental health concerns.
