AN ORDINANCE OF THE LEGISLATIVE BODY OF SALT LAKE COUNTY, UTAH, ADOPTING SECTION 2.100 OF THE SALT LAKE COUNTY CODE OF ORDINANCES, 2001, ENTITLED "COUNTY TRANSPORTATION ADVISORY COMMITTEE"

The County Legislative Body of Salt Lake County ordains as follows:

SECTION I: Salt Lake County Code of Ordinances, Chapter 2.100 COUNTY TRANSPORTATION ADVISORY COMMITTEE, is hereby adopted as follows:

Ordinance Number 2.100.010 - County Transportation Advisory Committee

There is created the County Transportation Advisory Committee, hereinafter referred to as the "Committee." The Committee shall review proposed transportation and public transit projects, rank projects and recommend the allocation of Funds.

The Committee shall be composed of thirteen members:

- (1) six members who are residents of Salt Lake County, nominated by the Mayor and confirmed by the Council who are:
 - (A) members of a local advisory board of the Transit District of Utah as defined in Utah Code Ann. § 17B-2a-802;
 - (B) Council members; or
 - (C) other residents with expertise in transportation planning and funding;
- (2) seven members recommended by the Council of Governments (COG), nominated by the Mayor and confirmed by the Council, chosen from mayors and/or city managers of cities, metro-townships, and towns within the county. The Mayor may nominate individuals other than those recommend by COG.
 - (A) The Mayor, in making nominations, may consider factors including, but not limited to, geographic diversity.

Ordinance Number 2.100.020 – Definitions

For the purposes of this chapter, the following terms, phrases, words, and their derivations shall have the meanings given in this section.

"Committee" means the County Transportation Advisory Committee.

"Council" means the Salt Lake County Council.

"Funds" means County of the First Class Highway Projects Funds

"Mayor" means the Mayor of Salt Lake County.

Ordinance Number 2.100.030 – Quorum

A majority of members of the Committee constitutes a quorum. As long as a quorum is present, Committee actions will be determined by a majority vote.

Ordinance Number 2.100.040 – Term Length

Members of the Committee will serve three year terms. Initially appointments shall be made for one, two or three year term.

Ordinance Number 2.100.050 – Member Removal Procedure

The Committee may recommend removal of a member by a two-thirds vote of the full Committee. Committee members may only be removed by the Mayor with the advice and consent of the Council.

Ordinance Number 2.100.060 – Committee Leadership

Chair and other officers of the Committee shall be decided by Committee vote. Any disputes or ties will be resolved in favor of the longest-tenured candidate.

Ordinance Number 2.100.070 – Meetings

The Committee shall meet at least annually, as necessary to timely evaluate projects.

Ordinance Number 2.100.080 – Compensation

Committee members shall not be compensated.

Ordinance Number 2.100.090 – Project Prioritization and Ranking Criteria

The Committee shall evaluate, rank and prioritize proposed public transit projects and regionally significant transportations facilities according to criteria including, but not limited to:

- (1) Regional and countywide economic development impacts
- (2) Improved local access to:
 - (A) employment;
 - (B) recreation;
 - (C) commerce; and
 - (D) residential areas

Ordinance Number 2.100.100 - Reporting

After reviewing and ranking each proposed project, the Committee shall provide a report detailing its recommendations and rankings to the Mayor and Council.

SECTION II: This ordinance shall become effective fifteen (15) days after its passage and upon at least one publication of the ordinance or a summary thereof in a newspaper published and having general circulation in Salt Lake County.
