A RESOLUTION OF THE SALT LAKE COUNTY COUNCIL AMENDING THE
MATTRESS DISPOSAL FEE AT THE SALT LAKE VALLEY SOLID WASTE
MANAGEMENT FACILITY

W I T N E S S E T H

WHEREAS, Salt Lake County is a co-owner and operator of the Salt Lake Valley Solid Waste Management Facility; and

WHEREAS, on June 27, 2018, the Salt Lake Valley Solid Waste Management Council voted to rescind the policy regarding mattress disposed at the Landfill (see Exhibit 1) and amend the Salt Lake County Landfill Fee Schedule to include a flat rate fee of \$15.00 for each mattress disposed of at the Salt Lake County Landfill; and

WHEREAS, it has been determined that the best interests of Salt Lake County and the general public will be served by charging a \$15.00 disposal fee for each mattress disposed of at the Salt Lake County Landfill; and

WHEREAS, pursuant to Section 3.42.040 of the Salt Lake County Code of Ordinances, new fees imposed by Salt Lake County agencies may be adopted at any time by resolution of the County Council.

R E S O L U T I O N

NOW, THEREFORE, IT IS HEREBY RESOLVED by the County Council of Salt Lake County that the Landfill Mattress Policy is rescinded and the Salt Lake County Landfill fee schedule is amended to add a \$15.00 mattress disposal fee for each mattress brought to the Salt Lake County Landfill effective as of the date below.

Salt Lake Valley Solid Waste Management Policy

Purpose

To encourage the recycling of mattresses in Salt Lake County; and to increase the available space in the Salt Lake Valley Landfill by reducing the number of mattresses disposed therein.

1. Policy

The Salt Lake Valley Landfill will accept mattresses and shall transport them to a local recycler. Residential customers disposing four or more mattresses shall pay an additional fee to help offset the Landfill's recycling costs.

2. Definitions

- 2.1 The term "Mattress" means a mattress, a mattress foundation or a box spring.
- 2.2 The term "Mattress" does not include a futon, a crib mattress or a pet bed.

3. Procedure

- 3.1 Standard Landfill disposal fees apply to all loads containing Mattresses. A customer may dispose up to three Mattresses for no additional fee; thereafter, the customer shall pay an additional fee of \$15 per Mattress over three.
- 3.2 A municipality or special service district engaged in a neighborhood cleanup program is exempt from this additional fee.
- 3.3 The Landfill may recycle the Mattresses it receives and may use the additional fee to help offset such recycling costs.
