DECLARATION OF DONATION

Friends For Animal Care and Effective Solutions, a Utah non-profit corporation and 501(c)(3) organization ("FACES"), irrevocably gives, and where appropriate transfers title to the property described below (the "Donation") to Salt Lake County (the "County") to become permanent property of Salt Lake County and to be administered in accordance with its established policies. FACES hereby assigns and transfers all rights to the property described below without restrictions or conditions EXCEPT those noted below under "Other provisions or restrictions."

Description of Donation:

The Donation consists of cash in the amount of \$100,000. The Donation will be transferred to the County as follows:

- Initial payment of \$75,000 to be made upon the acceptance of the Donation by the County Council;
- A final payment of approximately \$25,000 to be made upon the winding up of FACES. Such payment shall be made no later than 30 days following the final closeout of FACES financial activity and posting of the final IRS reports.

<u>Value</u> (estimated by the donor):

- \$100,000

Date of Transfer of Title and Delivery:

- Within five business days following the acceptance of the Donation by the County Council
- Delivery shall be made in the form of a check.

Other Provisions or Restrictions:

The Donation is intended to create an endowment fund to be known as the Utah FACES Animal Care Endowment Fund, which shall be placed in a Reserved Fund Balance Account to be invested and used to assist the Salt Lake County Animal Services Division, specifically its animal shelter located at Salt Lake County Animal Services, belay the costs of certain services, listed below. A reasonable amount of the income from the Donation may be used each year for ONLY the following services, listed in the order of priority.

- 1- Grooming Transport [To allow the animals in the shelter to be properly groomed
- 2- Microchips [To allow the County to purchase microchips during the year
- 3- Injured Animal Care [[To allow injured animals in the shelter to receive treatment that is outside what the shelter clinic can provide]

¹ The income used each year should be limited and should take into consideration the intent that the fund grow over time in order to-produce more income.

4- Spay and Neuter surgeries - [To provide spay and neutering services to animals that do not have access to other financial resources]

Grooming Transport Program funds and Injured Animal Care funds may only be used for animals that are sheltered and, in the care, and control of Salt Lake County Animal Services. Support for Microchips and for Spay and Neuter Surgeries may be extended to all residents of Salt Lake County as they have been in the past. It is expressly understood that no funds may be used for salaries or other personnel expenditures or for any other expenditures that are not directly related to the care and treatment of animals.

The Board asks that the County Treasurer be asked to keep and maintain the funds in a separate account which is dedicated solely to Animal Services and that the County Treasurer invest and manage the funds as an endowment and distribute the income only to support the Animal Services Division in the manner described in the attached Declaration of Donation.
