Council Member DeBry read the following proclamation recognizing the passing of Senator John McCain, stating he lived an exemplary life:

PROCLAMATION OF THE SALT LAKE COUNTY COUNCIL RECOGNIZING THE LIFE OF UNITED STATES SENATOR JOHN MCCAIN

WHEREAS, in recognition of a lifelong legacy of service in the United States Navy and the United States Senate, on behalf of the citizens of Salt Lake County, we honor United State Senator John McCain, a true American hero who devoted his entire life to his country, and;

WHEREAS, Senator McCain graduated from the US Naval Academy in 1958 and became a naval aviator. While on a mission during Operation Rolling Thunder over Hanoi in October 1967, he was shot down, breaking both arms and a leg, and captured by the North Vietnamese, and;

WHEREAS, Senator McCain was a prisoner of war until 1973, refusing to be released early until all prisoners captured prior to him were also released, and;

WHEREAS, after retiring from the Navy in 1981 he was elected to the US House of Representatives in 1982 and the US Senate in 1987; and;

WHEREAS, Senator McCain ran for President in 2000 and 2008, losing to President George W Bush and President Barack Obama, yet asked both men to deliver the eulogy at his funeral, and;

WHEREAS, when Senator McCain was diagnosed with cancer in July of 2017 he said that in addition to undergoing cancer treatment, he planned to "celebrate, with gratitude, a life well-lived," and;

WHEREAS, Senator McCain had an optimism for America. His farewell letter to Americans stated the following: "Do not despair of our present difficulties but believe always in the promise and greatness of America, because nothing is inevitable here. Americans never quit. We never surrender. We never hide from history. We make history. Farewell, fellow Americans. God bless you, and God bless America."

NOW, THEREFORE, The Salt Lake County Council, in recognition of Senator John McCain and his years of service to our great country, our county and its citizens, do hereby express our deep appreciation for his dedication to service. We extend to his family our sincere sympathy upon his passing.

The plaque will be fixed upon or located on the grounds of the District Attorney building, the location where Sergeant Pierce was killed:

RESOLUTION NO. 5415

A JOINT RESOLUTION OF THE SALT LAKE COUNTY COUNCIL AND SALT LAKE COUNTY MAYOR TO ERECT A PLAQUE HONORING SALT LAKE CITY POLICE DEPARTMENT SERGEANT NEPHI PIERCE

WHEREAS, on November 27, 1922, Salt Lake City Police Officers Sergeant Nephi Pierce and Officer George Watson were on foot patrol near the intersection of 500 South and Main Street in Salt Lake City, Utah, when they approached two robbery suspects; and

WHEREAS, one of the suspects drew a gun and shot Sergeant Pierce in the abdomen, severing his spine; and

WHEREAS, on March 26, 1923, Sergeant Pierce died of the wounds he received in the line of duty. Three months after his death Sergeant Pierce's wife, Marie Pierce, committed suicide in the couple's home. Sergeant Pierce and his wife are buried beside each other in Mount Olivet Cemetery in Salt Lake City; and

WHEREAS, the Salt Lake City Police Department and Salt Lake City Police History Project has erected plaques throughout Salt Lake City to honor officers killed in the line of duty and has sought to erect a plaque to memorialize and honor Sergeant Pierce; and

WHEREAS, Salt Lake County has recently built the Salt Lake County District Attorney's Office near the location where Sergeant Pierce was mortally wounded; and

WHEREAS, the Salt Lake City Police History Project has asked the Salt Lake County District Attorney's Office for permission to display a permanent plaque, similar to the proof of which is attached to this Resolution, honoring Sergeant Pierce and all of Salt Lake City's fallen officers; and

WHEREAS, Salt Lake County and the Salt Lake County District Attorney's Office work closely with the Salt Lake City Police Department and proudly support that office and law enforcement throughout the State of Utah;

NOW, THEREFORE, be it jointly resolved by the Salt Lake County Council and the Salt Lake County Mayor:

That the Salt Lake County District Attorney's Office is authorized to cooperate with the Salt Lake City Police History Project as necessary to arrange for a permanent plaque honoring Sergeant Nephi Pierce, to be affixed upon or located on the grounds of the Salt Lake County District Attorney's Office located at 35 East 500 South, Salt Lake City, Utah.

AN ORDINANCE OF THE LEGISLATIVE BODY OF SALT LAKE COUNTY, UTAH, AMENDING CHAPTER 2.88 AND SECTION 19.86.020 OF THE SALT LAKE COUNTY CODE OF ORDINANCES, 2001, TO UPDATE THE COMPOSITION AND DUTIES OF THE HISTORIC PRESERVATION COMMISSION TO ADDRESS CHANGES CAUSED BY COMMUNITY PRESERVATION IN SALT LAKE COUNTY.

The Legislative Body of Salt Lake County ordains as follows:

SECTION I. The amendments made herein are designated by underlining the new substituted words. Words being deleted are designated by brackets and interlineations.

SECTION II. Chapter 2.88 of the Salt Lake County Code of Ordinances, 2001, entitled "Historic Preservation Commission," is amended to read as follows:

2.88.020 - Establishment.

An historic preservation commission is hereby established by Salt Lake County with the following provisions:

- 1. The Commission for the Mountainous Planning District shall consist of those persons who sit on the Mountainous Planning District Planning Commission. The Commission for the remainder of the unincorporated Salt Lake County shall consist of those persons who sit on the Salt Lake County Planning Commission. [seven members with a demonstrated interest, competence, or knowledge in historic preservation, appointed by the mayor with the advice and consent of the county council. The members of the commission shall be appointed to staggered terms of three years, provided that members may be appointed to terms longer than three years when necessary to provide for staggered terms. These terms are renewable. The members of the commission shall be residents of the unincorporated area of the county].
- 2. To the extent <u>practical</u>, <u>subject to the membership requirements for</u> the respective planning commissions prescribed in sections <u>19.05.010 and 19.07.020</u>, [available in the unincorporated area of the county,] [two] <u>one</u> commission member[s shall] <u>should</u> be <u>a</u> professional[s], as defined by National Park Service regulations, from the disciplines of history, archaeology, planning, architecture or architectural history.
- 3. The commission may hold meetings at such times as the commission determines it is necessary. The commission shall conduct business in accordance with the Open Public Meeting laws of Utah. This includes public notification of meeting place, time and agenda items.
- 4. Written minutes of each commission meeting shall be prepared and made available for public inspection.

SECTION III. Section 19.86.020 of the Salt Lake County Code of Ordinances, 2001, is amended to read as follows:

19.86.020 - Historic sites designated.

[A. Existing Sites. Each of the following structures and sites in the unincorporated area of the county is a historic site:-

1. Little Dell Station, Mountain Dell Canyon.

- 17. Mill Creek Farm House, 1106 East 4500 South, Millcreek Township.
- B. Amendments.] The county council may [amend the above list of] designate historic sites and structures after receiving a recommendation from the Historic Preservation Commission/Planning Commission in accordance with section 2.88.030 and [, including designating additional historic sites subject to the amendment procedures in] Chapter 19.90 of this code. County Council designated historic sites shall be on file with the Planning and Development Services Division.

SECTION IV. This ordinance shall become effective fifteen (15) days after its passage and upon at least one publication of the ordinance or a summary thereof in a newspaper published and having general circulation in Salt Lake County.
