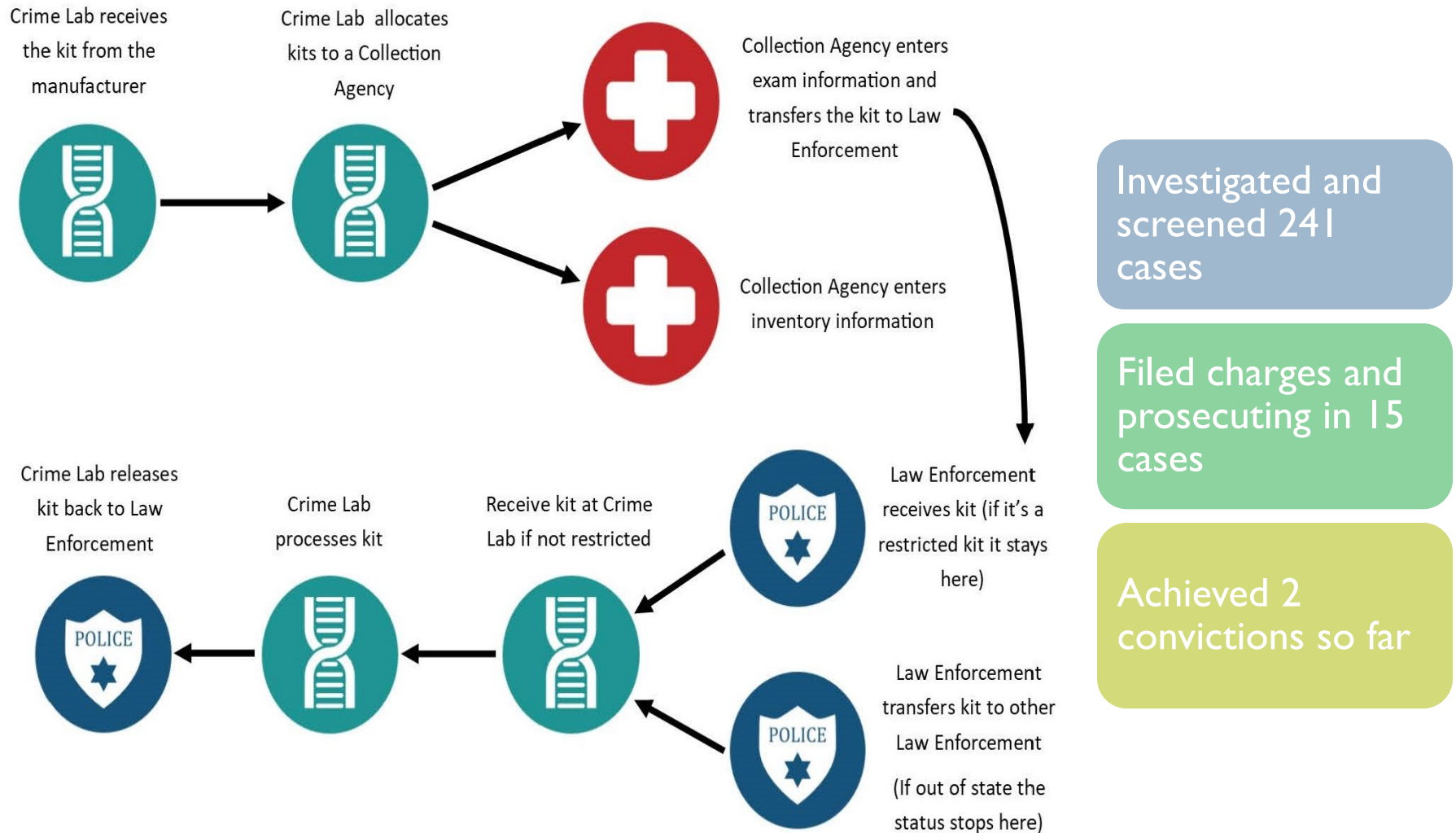

The Salt Lake County District Attorney's Office Victim Services Program was awarded Federal VOCA (Victims of Crime Act) grant funding totaling \$598,237

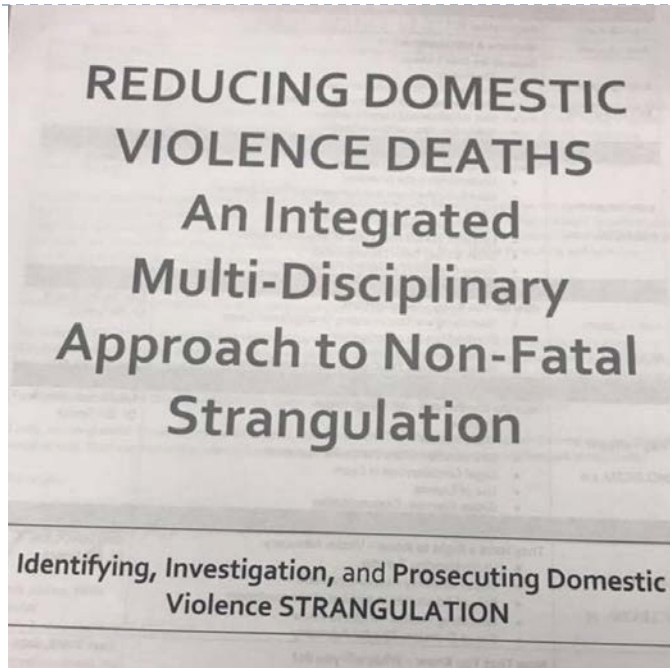
The grant has allowed the District Attorney's Office to hire five Case Managers, who provide social work case management and outreach service to victims of crime.

1,474 individuals have received services, the vast majority of whom previously may not have been able to receive services.

- Providing information about everything from the criminal justice process and victims' rights, to crisis intervention and connection to community resources.

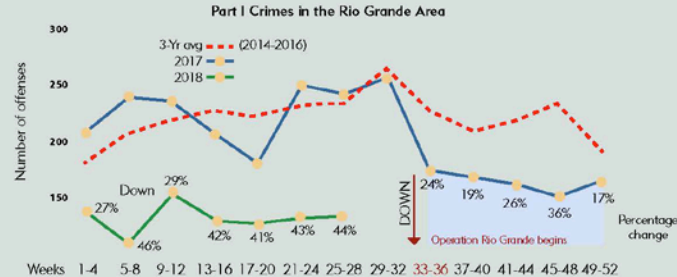

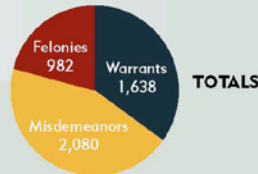
OVERALL OUTCOME: Improve public safety and order in the Rio Grande area.

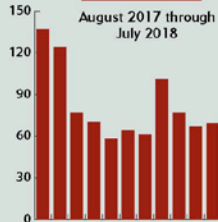

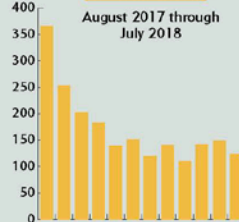

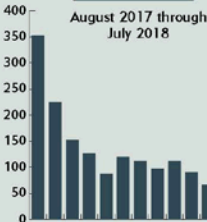

Competency Evaluations

National – 20% - 25% found incompetent, Utah – 54% found incompetent

Statutory procedure now limits competency evaluations to one court-appointed examiner instead of two.

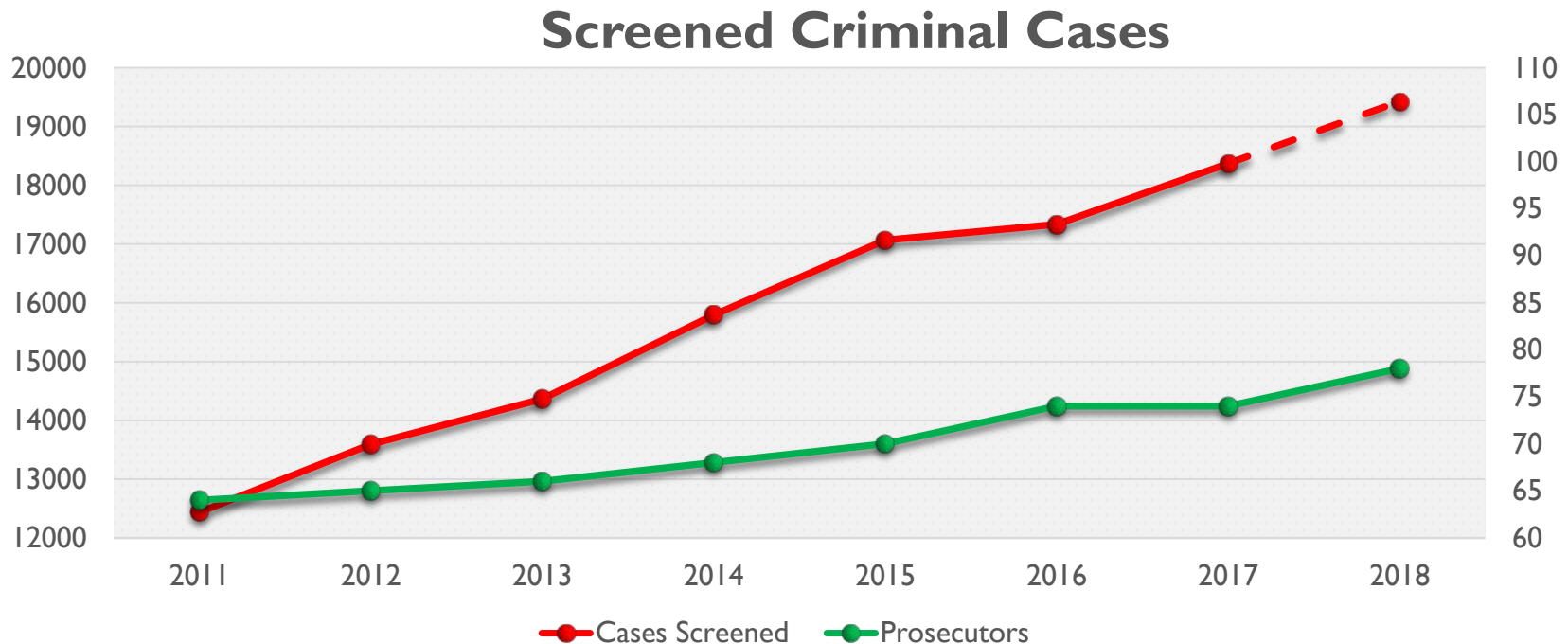
County will be responsible for the cost of retaining a second examiner in any case in which it finds issues with the single examiner's opinion.

Will evaluate the financial effect of this on our budget over the next year.



Challenge – Continued Increase in Screening of Adult Criminal Cases

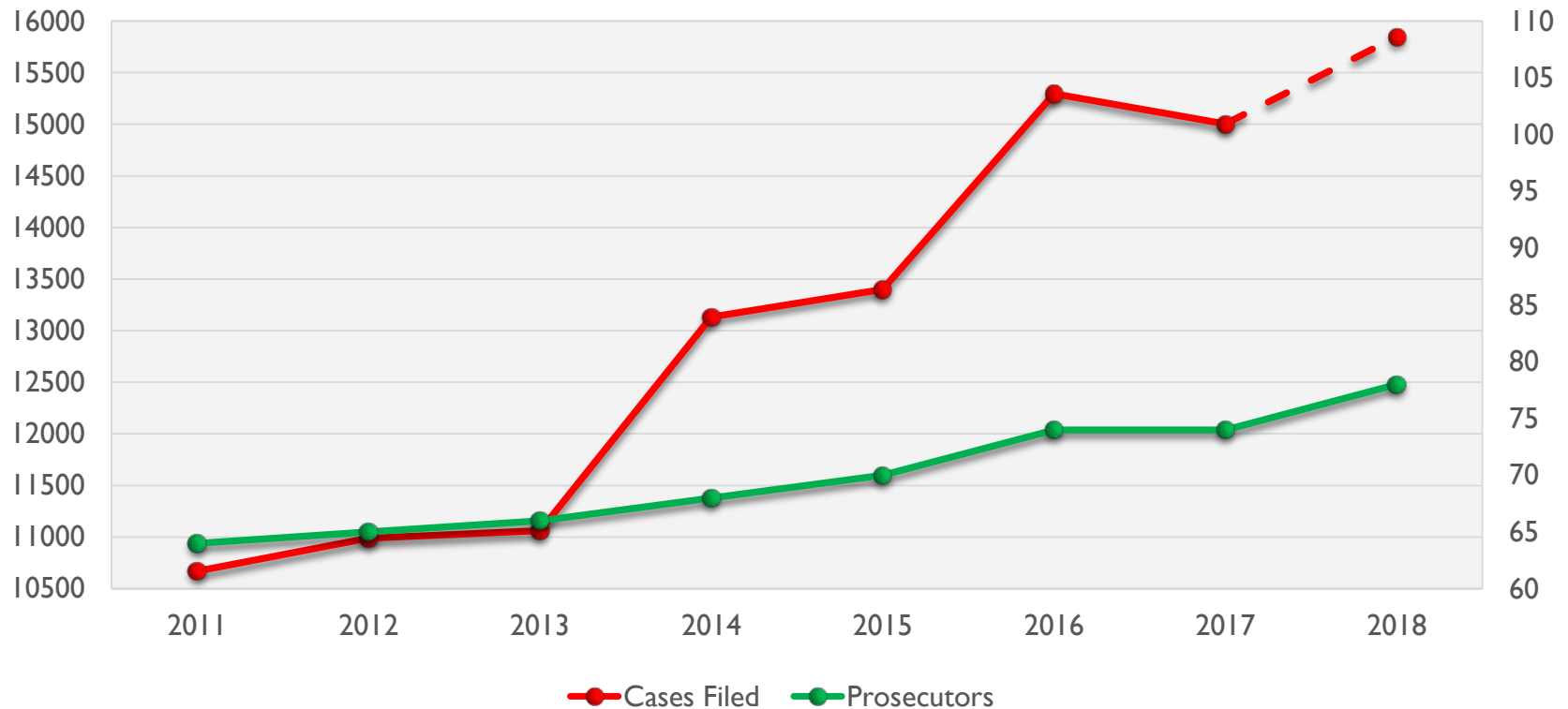
- ▶ In 2011, the District Attorney's Office screened 12,436 cases for criminal charges.
- ▶ In 2018, the District Attorney's Office is on track to screen 19,425 cases for criminal charges.
- ▶ ***The District Attorney's Office is handling an additional 7,000 adult cases with only 14 more prosecutors than 2011.***



Challenge – Continued Increase in Filing of Adult Criminal Charges

In 2018, the District Attorney's Office is on track to file 15,850 criminal cases.

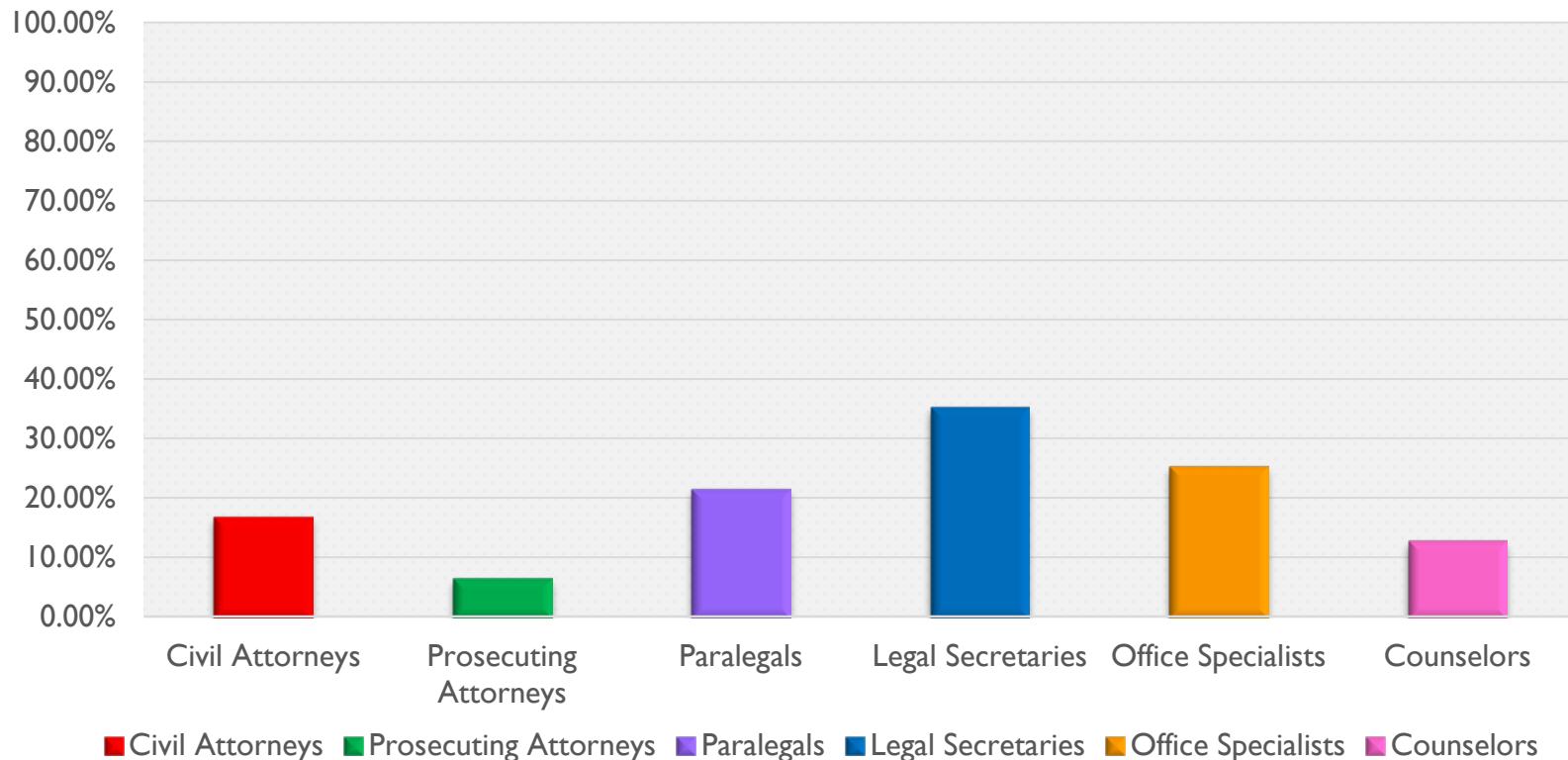
Cases Filed

Mentor Corps Boot Camp



Since its inception in 2015, 95 veterans admitted, 35 graduates, 37 in various stages of the program and 23 who did not complete

In 2018 so far, we've had 12 veterans enter the program; 9 graduates, and we expect to graduate 3 more before year's end

In 2018, we had 2 of our graduates become Veterans Court Mentors and added to our staff of mentors—a first for our court.
