I instigated a contract with eUtah in 2000 to design an Internet Website offering licensing verification and renewal of licensing, both on-line by 2001, reduced the case load with the Utah Attorney General's office by instituting a monthly review of all cases and entered into a memorandum of understanding, whereby DOPL paid an Assistant Attorney General housed within DOPL's Enforcement Bureau to hasten case review and stipulation orders; initiated significant legislation facilitating less regulation of the Construction Trades and Health Professions; and resolved high profile disciplinary hearings, which drew a lot of media attention, to the benefit and protection of the public.
