All,

After reading the description in the budget adjustment request form, I think this FTE *should* be included in the indirect cost plan, but should be allocated 100% to CJS. A twist or nuance to this would be that the allocated costs to Criminal Justice Services for this FTE would be subject to a one-year lag; e.g., the 2018 costs for this FTE wouldn't be charged to CJS until 2019, the 2019 costs wouldn't be charged until 2020, etc.
