Consideration of 2018 Veterans Exemption After the Sale of the Property or Other Change in Re:

Ownership After the Lien Date for Robert W. Douglas, Parcel # 26-25-101-017

Council Members:

The Property Tax Committee, at a meeting on December 20, 2018, considered an application for 2018 Veterans Exemption due to the sale of the property or other change in ownership, after the lien date. The Committee recommends that the following relief be granted:

Action	Type of Relief	Amount of Relie
Approve	Veterans Exemption	\$ 1,553.37

The refund formula for Veterans Exemption tax relief is in Utah statute 59-2-1105 (4) which states, "A county that grants an exemption under Section 59-2-1104 to a claimant shall refund to that claimant an amount equal to the amount by which the claimant's property taxes paid exceed the claimant's property taxes due, if that amount is \$1 or more." State Tax Commission appeal # 17-2022 further defines a claimant's property taxes paid to be the sum of property taxes the claimant paid plus the amount of their tax relief credit or abatement and does not include amounts paid by a third party such as a buyer.
