RE: Resignation of Stephen W. Owens
Trustee, Jordan Valley Water Conservancy District

Dear Mr. Snelgrove:

I am writing to inform you that Stephen W. Owens' service on the Jordan Valley Water Conservancy District's Board of Trustees will end on July 25, 2019. He has given his notice of resignation, effective on that day. This is a mid-term resignation, since the term to which he was appointed by Governor Herbert will expire in January 2022. Mr. Owens represents the District's Division No. 7, which includes all of Jordan Valley's retail water service in unincorporated Salt Lake County lands (located in Granite Park, South Cottonwood, and Union-Willow Creek); retail water service within portions of several cities (City of Holladay, Murray City, Riverton City, and the City of South Salt Lake); and lands served by White City Water Improvement District.

The Salt Lake County Council may submit to Governor Gary R. Herbert three nominees for the position to fill the remaining period of the current term (through January 2022). Governor Herbert has asked that a resume be included for each nominee. However, the Council may submit fewer than three nominees if the body certifies in writing to the Governor that, after reasonably diligent effort, the body is unable to identify three nominees who are willing and qualified to serve as trustee. Each nominee must reside within the District's boundaries and be a registered voter at that residence.
