AMENDMENT NO. 1 of the INTERLOCAL COOPERATION AGREEMENT

between

SALT LAKE COUNTY

and

DRAPER CITY

This Amendment No. 1 between **SALT LAKE COUNTY**, a body corporate and politic of the State of Utah ("County") and **DRAPER CITY**, a municipal corporation of the State of Utah ("City"). The County and the City may each be referred to herein as a "Party" and collectively as the "Parties."

RECITALS:

- A. The Parties previously entered into an Agreement (County Contract No. 0000001697) in which the County agreed to disburse \$5,800,000 to the City from funding authorized by UTAH CODE ANN. § 63B-27-102 as part of Senate Bill 277 (2017) to reimburse Draper for authorized transportation projects;
- B. Under that Agreement, the Parties allocated \$3,200,000 to the Lone Peak Parkway Extension Phase II project and \$2,600,000 to the Traverse Ridge Road Improvement Project;
- C. The Parties would like to reallocate \$224,200.79 originally allocated to the Lone Peak Parkway Project to the Traverse Ridge Road Project;
- D. The Parties want to amend Exhibit A of the underlying Agreement to reflect the reallocation of money as set forth herein.

NOW THEREFORE, in consideration of the mutual promises contained in this Agreement and in compliance with and pursuant to the provisions of the Interlocal Cooperation Act, the Parties hereby agree that Exhibit A of the abovementioned Agreement is amended as set forth in Exhibit A of this Amendment:

1. All Parts, Paragraphs, Attachments and other provisions of the Agreement and any prior amendments thereof not specifically modified by this amendment shall be the same and remain in full force and effect.

EXHIBIT AProject Descriptions

PROJECT DESCRIPTIONS for DRAPER CITY

1) Project Title: Lone Peak Parkway (125 West) Extension Phase II

Project Description:	New road construction (extension of Lone Peak Parkway from 12950 South to 13200 South) with a total right-of- way width of 100 feet. In general, the side treatments shall consist of a 10-foot wide trail with a 5-foot wide park strip on one side and a 5-foot wide sidewalk with a 10-foot wide park strip on the other side. The roadway will include two traffic lanes (one in each direction), a turn lane, and two bike lanes designed and constructed in accordance with Salt Lake County's Bikeway Design and Wayfinding Protocol. The project to include the construction of storm drain and other utilities and a box culvert at the crossing with the Jordan and Salt Lake City Canal.	
Maximum Reimbursable Amount:	\$2,975,799.21	

2) Project Title: Traverse Ridge Road Improvements

Project Description:	Reconstruction of Traverse Ridge Road from 610 East to 2070 East; installation of curb and gutter and storm drain; erosion repair; and replacement of guard rail to meet current standards. This project to also include storm drain installation to Potato Hill trail head parking.
Maximum Reimbursable Amount:	\$2,824,200.79
