## BRIEF HISTORY con't Attachment #1

The Sojourner Group was formally established as a 501c3 in Salt Lake City, UT in 2013. The Founder consistently heard disparaging stories of women expressing the need for culturally appropriate services that would support healing from their experiences of sexual and domestic violence. A silenced victim/survivor stands unprepared, yet likely, to experience a lifetime of poor mental health.

The Founder's research found that Utah is unique in that there are no culturally specific services to African American/Black victim/survivors of sexual and domestic violence. The Founder attended Women of Color Conferences with a focus on sexual assault and domestic violence in North Carolina, Maryland, and Nevada, only to learn that such organizations are actively involved in work across the United States. She found herself sitting at the table with social workers, providers, and advocates from Native, African American/Black, Asian, and Mexican populations. The first speaker, an Asian woman, spoke about elders in her culture telling her to stay away from this type of work. Their philosophy: this work is white women's work. Mainstream organizations and providers attempt to speak to cultural experiences for victimized survivors from numerous ethnic groups, however, the understanding of cultural norms, family practices, or spiritual understanding is often taken too lightly or completely misunderstood.

In 2012, the U S. Census Bureau reported the Black or African American population at 1.0%. The growth from 2012-2018 indicates that the population is now at 1.4%, a growth of 0.4%. Very little, if anything, has been changed to provide cultural services for victimized African American/Black women in Utah.

The American Psychological Association (APA) reveals three key points that should concern us:

**1) Social isolation** and chronic loneliness place individuals at much greater risk for a variety of diseases, as well as for premature mortality.

**2)** Loneliness is defined by a person's perceived level of social isolation and is not synonymous with chosen solitude.

**3)** Cognitive Behavioral Therapy (CBT) therapy (focused on addressing negative self-worth and interventions that bring people together through community groups) appears to be effective at combating loneliness among older adults."

The National Alliance on Mental Health (NAMH) notes:

"African Americans sometimes experience more severe forms of mental health conditions due to unmet needs and other barriers. According to the Health and Human Services Office of Minority Health, African Americans are 20% more likely to experience serious mental health problems than the general population. Common mental health disorders among African Americans include: Major depression; Attention deficit hyperactivity disorder (ADHD); Suicide, among young African American men; Posttraumatic stress disorder (PTSD), because African Americans are more likely to be victims of violent crime. https://www.nami.org/Find-Support/Diverse-Communities/African-American-Mental-Health

A 2017 article from the *Institute for Women's Policy Research*: Violence Against Black Women found:

Black women disproportionately experience violence at home, at school, on the job, and in their neighborhoods. Black women face high rates of intimate partner violence, rape, and homicide. Black girls and women also experience institutionalized racism; they are disproportionately punished in school, funneled into the criminal justice system after surviving physical or sexual abuse, disproportionately subjected to racial profiling and police brutality, and incarcerated at rates far exceeding their share of the population.

The Founder and Executive Director was forced to put the work of The Sojourner Group on hold to care for her aging parents who live out of state. She has since returned to continue the work started in 2013.


