Mr. Michael Shea, Environmental Program Manager, delivered a PowerPoint presentation on H.B. 411 - Community Renewable Energy Act. He reviewed what H.B. 411 is and why the resolution is in the best interest of county residents and businesses.

Mr. Tyler Polson, Sustainability Program Manager, Salt Lake City, continued the PowerPoint presentation reviewing the six key steps outlined in H.B. 411. The County will need to adopt a resolution by December 31, 2019, committing to a goal that 100 percent of the annual electric energy supply will come from a renewable energy resource by 2030. Residents within the communities will have an option to opt out of the program. There will be a cost of approximately \$10,000 to pay for the initial round of noticing.

Mayor Jennifer Wilson stated this agreement would allow Rocky Mountain Power to move forward in the process of looking at renewable sources within Salt Lake County and would give residents in the unincorporated areas an option.

Council Member Bradley asked if renewable energy was cheaper than fossil fuel.

Mr. Polson stated no, renewable energy does cost more than fossil fuel. However, the cost of renewable energy has been decreasing over the last few years.

Mr. Travis Tanner, Rocky Mountain Power, stated Rocky Mountain Power supports this bill.

Council Member Snelgrove stated he would like Mr. Shea to investigate the following areas in order to reduce the use of energy waste within Salt Lake County government:

- Repurposing kitchen waste into bio-fuels
- Having County facilities generate their own energy
- Adopting policy of using xeriscaping
- Sending out a memo telling agencies to stop watering until next summer
- Smart water controllers

Mr. Darrin Casper, Deputy Mayor of Finance and Administration, stated Mayor Jennifer Wilson will be proposing an 8.6 percent tax increase for the 2020 budget year due to a \$5 million structural deficient, and an increase in employee compensation, as well as other mandated costs.
