Mr. Steve Van Maren asked if there was any information available on this lease.

**Mr. Martin Jensen**, Director, Salt Lake County Parks & Recreation Division, stated the County is considering leasing a small piece of property at the South Mountain Golf property to a private/public entity to allow for the construction and use of an event center to host weddings, conferences, or corporate events. The County has already gone out with a RFP and has selected a company. Negotiations are currently taking place. Once the negotiations are done and the lease agreement is ready, it will come back before the

Council for formal action.

**Council Member Bradshaw** asked why a public hearing needed to be held. The Council is not selling the property.

**Mr. Derrick Sorensen**, Real Estate Manager, stated recently the Council adopted an ordinance stating that a public hearing had to be held on changes to significant properties.

Mr. Van Maren stated he was concerned with the reduction of parking spaces.

**Mr. Jensen** stated the parking lot is not being reduced; it is being shared. The golf patrons will use the parking lot during the day and people attending the event center will use it in the evening.

**Mr. Mitchell Park**, Legal Counsel, Council Office, stated today the Council is receiving comments from the public; no legal action will be taken.

# A RESOLUTION OF THE SALT LAKE COUNTY COUNCIL DECLARING SALT LAKE COUNTY'S INTENT TO PARTICIPATE IN THE UTAH COMMUNITY RENEWABLE ENERGY ACT

WHEREAS, the 2019 Utah Legislature passed, and Governor Gary Herbert signed, H.B. 411, Community Renewable Energy Act, Utah Code Ann. § 54-17-901, et seq., ("the Act");

WHEREAS, the Act authorizes the Utah Public Service Commission to establish a community renewable energy program whereby counties, acting on behalf of their residents in the unincorporated area of the county, may cooperate with qualified utilities to provide electric energy for participating customers entirely from renewable energy resources; and

WHEREAS, the Act requires participating counties to adopt a resolution no later than December 31, 2019, that states a goal of achieving an amount equivalent to the 100 percent of the annual electric energy supply for participating customers from a renewable energy resource by 2030; and

WHEREAS, it is in the interest of Salt Lake County and its residents to participate in the Act, and to state and affirm such a goal;

NOW, THEREFORE, be it resolved by the Salt Lake County Council that Salt Lake County shall;

1) Establish a goal of achieving an amount equivalent to 100 percent of the annual electric energy supply for participating customers in the unincorporated county from a renewable energy resource by 2030; and

2) Pending program approval and development by the Utah Public Service Commission, begin the process of fulfilling the Act's program requirements as described in Utah Code Ann. §54-17-903, including entering into an agreement with a qualified utility, and adopting an ordinance approving the program.

# RESOLUTION NO. 5719

A RESOLUTION OF THE SALT LAKE COUNTY COUNCIL AUTHORIZING EXECUTION OF TWO ROADWAY DEDICATION PLATS AFFECTING PORTIONS OF THE MAGNA REGIONAL PARK

# RECITALS

A. Salt Lake County ("County") owns land located at approximately 4042 South 7200 West, Magna, Utah identified as Parcel No. 14-33-406-002 (the "County Parcel"). The County is currently developing this parcel into a regional park.

B. As part of obtaining approvals from Magna Metro Township ("Magna") to develop the regional park. Magna has requested that the County dedicate a portion of the County Parcel adjacent 7200 West (the "7200 West Dedication Area") and a portion of the County Parcel along Valley Forge Road (the "Valley Forge Road Dedication Area") for public use. The 7200 West Dedication Area and the Valley Forge Road Dedication Area are collectively referred to as the "Dedication Areas."

C. The County Real Estate Division recommends that the Dedication Areas be dedicated to public use for no fee with the consideration for the conveyance being that Magna shall use the Dedication Area as part of the public roadway system.

D. The County has caused the 7200 West Roadway Dedication plant (the "7200 West Road Plat"), a copy of which is attached hereto as Exhibit 1, to be prepared in order to dedicate the 7200 West Dedication Area to Magna for public use.

E. The County has caused the Valley Forge Road Roadway Dedication plat (the "Valley Forge Road Plat"), a copy of which is attached hereto as Exhibit 2, to be prepared in order to dedicate the Valley Forge Road Dedication Area to Magna for public use.

F. The County has determined that it is in the public interest to dedicate the Dedication Areas for public use as part of obtaining approvals from Magna for the development of the Magna Regional Park.

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Salt Lake County Council that the 7200 West Road Plat, attached as Exhibit 1, is hereby approved; and the Mayor and Clerk are hereby authorized to execute the 7200 West Road Plat on behalf of the County as owner of the 7200 West Dedication Area.

IT IS FURTHER RESOLVED by the Salt Lake County Council that the

Valley Forge Road Plat, attached as Exhibit 2, is hereby approved; and the Mayor and Clerk are hereby authorized to execute the Valley Forge Road Plat on behalf of the County as owner of the Valley Forge Road Dedication Area.
