

**FIRST AMENDMENT TO INTERLOCAL AGREEMENT  
FOR REFUSE AND RECYCLING SERVICES AT VARIOUS COUNTY FACILITIES**

This First Amendment to Interlocal Agreement for Refuse and Recycling Services at Various County Facilities (the “First Amendment”) is entered as of the effective date identified in Paragraph 4, by SALT LAKE COUNTY, a body corporate and politic of the state of Utah on behalf of its divisions included in Exhibit 1 to the First Amendment (the “County”) and the WASATCH FRONT WASTE AND RECYCLING DISTRICT, a special service district and public entity under the laws of the state of Utah (the “District”).

**RECITALS**

WHEREAS, the Parties are public agencies and are therefore authorized by the Utah Interlocal Cooperation Act, Utah Code Ann. §§ 11-13-101, *et seq.* (the “Interlocal Act”), to enter into agreements with each other for joint and cooperative action which will enable them to make the most efficient use of their powers on a basis of mutual advantage; and

WHEREAS, the Parties entered into that certain Interlocal Agreement for Refuse and Recycling Services at Various County Facilities in February 2015, and with a retroactive application to January 1, 2015 (the “Original Agreement”); and

WHEREAS, the term of the Original Agreement is set to terminate on December 31, 2019, but under Section 3 of the Original Agreement the Parties are authorized to extend the Original Agreement for an additional five (5) year term through December 31, 2024 by a written amendment signed by the Parties, and the Parties desire to so-extend the Original Agreement.

**TERMS**

NOW, THEREFORE, in consideration of the terms, conditions, mutual covenants, and payments herein described to be performed and paid, the Parties agree as follows:

1. Term Extension. Pursuant to Section 3 of the Original Agreement, the Original Agreement is hereby extended for a five (5) year term through December 31, 2024 (the “Second Term”).
2. Exhibit Replacement. Exhibit 1 of the Original Agreement, detailing the list of services and prices for those services, is replaced by Exhibit 1 of this First Amendment. Hereafter, changes to Exhibit 1 shall be made in accordance with the terms of Section 1 and 2 of the Original Agreement, which remain unchanged.
3. Amendment to Section 2 of the Agreement, entitled “Consideration” shall have the following paragraph added:



For the 2020 calendar year, the County shall pay the District pursuant to the rate schedule (the "Contract Price") detailed in Exhibit 1 for the defined services provided by the District. The fees shall include the actual costs to provide each of the services including personnel and other associated costs. For each subsequent calendar year, the District will update Exhibit 1, without a need for a signed amendment to the Agreement, by providing a minimum of four (4) months advance written notice to the County for any anticipated price increase or decrease. Upon request, the District will provide an explanation for any anticipated price increase or decrease. The District will provide a copy of the approved rate schedule to the County no later than December 15<sup>th</sup>.

4. Other Terms Unchanged. Except as expressly modified by this First Amendment, all terms and provisions of the Original Agreement, including Section 9 concerning compliance with the Interlocal Cooperation Act, shall remain in full force and effect.

5. Effective Date. This First Amendment will not take effect until: (a) it has been approved by both Parties as required by Sections 11-13-202(2) and -202.5 of the Interlocal Act, (b) it has been submitted to the attorney authorized to represent each Party for review as to proper form and compliance with law, as required by Section 11-13-202 of the Interlocal Act, and (c) it has been filed with the keeper of records of each Party, as required by Section 11-13-209 of the Interlocal Act.

6. Counterparts and Electronic Execution. This First Amendment may be executed in two or more counterparts, each of which shall be deemed an original, and all of which shall constitute one and the same instrument. This First Amendment may be executed by delivery of executed signature pages by electronic reproduction such as email or fax, and such emailed or faxed execution will be effective for all purposes.


