Re.: Letter of Understanding – Regional Transportation Choice Fund (4th Quarter)

Dear Mr. Jensen:

The purpose of this letter of understanding is to inform you that, pending County Council approval, Salt Lake County Regional Planning and Transportation intends to transfer \$1,720,000 to Salt Lake County Parks and Recreation from the Regional Transportation Choice Fund (4th Quarter).

The purpose of the funding is for improvements to be made to the Mount Olympus Trailhead. Specifically, the project entails removing asphalt and repaving to construct a parking lot of 48 stalls closer to Wasatch Boulevard; constructing a one-way parking lot traffic circulation with access from Wasatch Boulevard; striping and reconfiguring lanes along Wasatch Boulevard to accommodate turn lanes into the parking lot, including acceleration and deceleration lanes, and continuous bicycle lanes on both sides of Wasatch Boulevard; improving storm drains; and constructing new vault toilet and monument signs. The funds are restricted for these purposes.

The Office of Regional Development hopes that this project will be completed on or before December 31, 2024. If you and your department desire to accept the above listed funds for the purposes stated herein, and agree to make a good faith effort to complete the projects on or before December 31, 2024, please sign the letter and return a copy to me at RPerry@slco.org. 
