Rod.

The short answer is to proceed with the appropriation. Because there is no specific authority for the Mayor to appropriate moneys in an emergency situation, I would recommend the Mayor proceed and then seek remedial approval from the Council. At the next Council meeting the Council could approve the appropriation and delegate emergency appropriation powers to the Mayor. If the Council wants to set parameters for this delegation of appropriation authority it is within its power to do so.

One of the County's primary duties is to promote/protect the health safety and welfare of its citizens. As such, absent specific prohibition, it is appropriate for the Mayor to take such emergency action as necessary to fulfill this duty. The duties and powers of the Mayor are outlined in the County's optional plan, SLCo Ordinance and

state statute. Although there is not specific emergency authority, there are some catch all provisions in the optional plan and state, statute below.

The optional plan contains the duties of the Mayor and more specifically "The specific enumeration of executive powers herein shall not be construed to limit the executive powers of the County Mayor."

Utah Code Ann. § 17-53-301. states "A county executive may take any action required by law and necessary to the full discharge of the executive's duties, even though the action is not expressly authorized in statute.
