AMENDMENT NO. 2
of the
INTERLOCAL COOPERATION AGREEMENT
between
SALT LAKE COUNTY
and
MILLCREEK CITY

This Amendment No. 2 between **SALT LAKE COUNTY**, a body corporate and politic of the State of Utah ("County") and **MILLCREEK CITY**, a municipal corporation of the State of Utah ("City"). The County and the City may each be referred to herein as a "Party" and collectively as the "Parties."

RECITALS:

- A. The Parties previously entered into an Agreement for the transfer of funding to be used for regional transportation under the First Class Highway Projects Fund (County Contract No. 0000001760, DA Log No. 17-10059) ("the Agreement");
- B. The Parties have previously amended the Agreement to extend the term to December 31, 2019 and provide for additional extensions.
- C. The Parties want to extend the Agreement to extend the term to June 30, 2020 and provide for additional extensions.

AGREEMENT:

NOW THEREFORE, in consideration of the mutual promises contained in this Agreement and in compliance with and pursuant to the provisions of the Interlocal Cooperation Act, the Parties hereby agree that section 1.1, paragraph (k) is amended as follows:

- 1. Reimbursement Term: The reimbursement term is amended to terminate on the earliest of the following: (i) the date the City has been disbursed, in aggregate, the Maximum Reimbursable Amount, (ii) the date the agreement is terminated by either Party, or (iii) December 31, 2020.
- 2. All Parts, Paragraphs, Attachments and other provisions of the Agreement and any prior amendments thereof not specifically modified by this amendment shall be the same and remain in full force and effect.
