Mr. Gary Edwards, Director, Salt Lake County Health Department, updated the Council on the COVID-19 virus. He stated there has been a 77 percent increase in cases over the past 7 days. The group hit the hardest is white males between the ages of 21-40. There are 3,500 to 4,000 tests available per day. The results show that 5 percent of the people tested are coming back positive.

Mr. Clint Mecham, Salt Lake County Emergency Manager, updated the Council on the 5.7 earthquake that happened on March 18, 2020. He stated there has been over 550 aftershocks as of this morning. Damage assessment is ongoing with more damage being found then initially thought. Cyprus High School had a wall that partially collapsed that was in an area not normally occupied. The building is still safe for occupancy. West Lake Junior High had a wall collapse that was inside the normal occupancy range. This is a major concern and the building might be a write off at this point. There was minor damage to Fire Station 202 in Magna, but it can still be used. There were 49 house trailers that slid off their foundations, all but one

can be repaired. Governor Herbert is working on two Major Disaster Declarations (earthquake and COVID-19 virus) that will be forwarded to the Federal Government in the hope that additional funds will be available to mitigate these costs.

**Ms. Dina Blaes**, Director, Economic Impact Working Group, updated the Council on the work that is being done relating to the economic impact of the COVID-19 virus. She stated the working group started up two weeks ago; its purpose is to:

- 1) Meet with experts and people of different interest groups to discuss what everyone is seeing as well as to review new policies from the State and Federal Government.
- 2) Develop a clearing house by collecting information about different resources that are available not just for businesses as well as housing. This information is included on the County website. A business relief hotline was launch today to provide small businesses with additional resources that might be available.
- 3) Coordinate with local municipal economic development directors to see what measures they are taking within their municipalities to help lessen the impact, such as waiving fees for developments.
- 4) Look at areas within the small business sectors to make sure that all gaps are being filled. The County is also looking to restructure its small business loans to help those businesses affected by the COVID-19 virus.

Council Member Ghorbani stated she was concerned with the number of people that are unemployed and looking at being evicted.

Ms. Kerri Nakamura, Chief of Staff, Mayor's Office, stated the Mayor

only has the authority to defer evictions if the tenant has the COVID-19 virus. The Governor would have to act on any other reasons for eviction.

**Ms. Blaes** stated the group is also looking at how utility companies are going to handle deferred payments. Once the information is gathered, it will be on the County's website.

**Council Member Burdick** asked what was being done with the homeless population, including the unsheltered homeless population.

**Ms.** Erin Litvack, Operations Section Chief, updated the Council on what was being done to help the homeless population. She highlighted the following areas:

- 1) The health care providers for the homeless populations were educated on how to best handle the clients that reside in the resource centers. The Health Department is working with the medical providers to assign personal liaisons to help educate and answer questions relating to the virus.
- 2) Starting today, four street teams are going out into the community to locate the unsheltered homeless to check on them and educate them as well. The teams are made up of experts in many different areas so they can help this population.
- 3) The County is working with the health care providers to get them the medical equipment such as gloves and masks, which they need. It is also encouraging providers to put together their Continuity of Operations Plans (COOP).
- 4) The 4th Street Medical Clinic tests the homeless population for the virus and provides quarantined and isolation shelters if needed.

Council Member Burdick stated he would like an additional update next week on the homeless situation as well as what is happening at the jail.
