NEW TAX DEFERRAL APPLICATION - 2021 TAX SALE

Caine, John G., Parcel # (01W)15-02-456-021-0000, Category 202

(Recommend Approve Abatement and Hardship Deferral, Effective 07/15/2020)

The Property Tax Committee, at a meeting on July 16, 2020, considered an application for acceptance into the tax deferral program. The total delinquency of \$2,050.71 as of 07/15/2020 includes real property tax delinquencies plus penalties and interest.

The Committee recommends hardship abatement of \$739.80 and that the delinquent balance be deferred under Utah Code Section 59-2-1347 subject to the following conditions:

- 1. Monthly payments to the Salt Lake County Treasurer of at least \$75.00. Payments must be received by the end of each month and are to be applied to the delinquency;
- 2. All subsequent taxes be paid on or before the due date annually;
- 3. The participant retain their ownership interest in the property during the entire deferral period;
- 4. The property remain occupied during the entire deferral period as the participant's primary residence;
- 5. Yearly submission of an Application for Tax Abatement on or before the filing deadline; and
- 6. The deferral be reviewed annually prior to the Tax Sale for compliance with conditions of approval.

Failure to comply with the terms above may result in revocation of the deferral with the total delinquency due immediately.

With the deferral in place the County Auditor may withdraw the property from the 2021 Tax Sale.
