## **Reallocation of Active Transportation Funding**

The County receives \$7.00 out of the \$10 Motor Vehicle Registration fee that was facilitated by the Legislature and locally imposed by the County Council. \$5.00 of the Motor Vehicle Registration fee revenue services the debt on the 2014 and 2017 County Excise Tax Revenue Bonds and the remaining \$2.00 is stranded in the State's County of the First Class Highway Fund until legislative action is taken allowing the County access to the funds. Funds over and above the County's Excise Tax Revenue Bond debt service have provided funding for active transportation grants in the amount of approximately \$1M annually. A number of projects that have been funded throughout the years (since 2014) through this source of revenue, and have been completed, but we have a remaining balance since some projects came in under budget (a worksheet prepared by Vanessa Nelson is attached below for reference that provides details) or were canceled by the applicant for various reasons. All these projects were originally approved by Council and we currently have \$216,251.16 in funds that have been not requested for reimbursement since all the projects have been closed out.

Several months ago, two municipalities requested funds to help with cost overruns both for projects that are part of the TIGER First Mile Last Mile program being managed by Heather Bening at UTA. The projects have been vetted by Catherine Kanter, Mike Reberg, Dina Blaes, Ryan Perry, and Helen Peters.

## **Project Descriptions:**

- \$120,000 for Millcreek for the Main Street; Big Cottonwood Creek to 3900 South
   Project Description: Modifications to the existing roadway to provide for proper sidewalk
   grades; roadway striping including bike lanes, markings, and appropriate signage. The funding
   short fall was caused by increases in material and labor costs.
- \$82,776.24 for West Jordan for the Wasatch Meadows Dr. Railroad Crossing Project
   Description: Construction of sidewalk along Old Bingham Highway and Wasatch Meadows Drive
   at the railroad crossing at the Mid Jordan TRAX line. The funding short fall was caused by
   increases in material and labor costs.

## Requested project total: \$202,776.24

This will leave \$13,474.92 remaining from the total of funds (see below \$216,251.16 has been released from previous projects) that can be reallocated to other active transportation requests.
