| Request Description: | Parks & Recreation is nearing completion of the Big Cottonwood Park Softball Complex replacement project, approved for 2019. Through the course of construction, multiple unknown site conditions required additional work. A municipal sewer line was discovered and required an easement to be surveyed and two field lights relocated outside the new easement. These lights now require new LED lamps to provide adequate lighting for the fields. These unknown site conditions required substantial expenditures of the project's contingency. The complex has also experienced two instances of vandalism in the past month highlighting the need for security measures to be installed. In order to complete the project by providing phones for the dugouts, FF&E, and provide additional safety features, additional funds are needed. Parks & Recreation requests a funding transfer from the remaining available budget of the completed Northwest Rec boiler replacement project; no new County dollars are requested. | | | | | | | | |
