4.2 Information on the Nomination of Historic Magna Main <u>20-1015</u> Street to the National Register of Historic Districts

Ms. Dina Blaes, Director, Regional Transportation, Housing and Economic Development Department, stated following the March 18, 2020, earthquake, staff from the Utah Division of State History did an assessment of the damage sustained by Magna buildings. There is a great collection of historic structures on Magna Main Street. They found the funding necessary to nominate the Main Street area to the National Register of Historic Places. Such a designation would mean tremendous resources available for building owners and the business community.

Mr. Cory Jensen, Senior Preservation Program Specialist, Utah Division of State History, stated the nomination will go before the State History board on October 29, 2020. If the area meets the qualifications, the nomination will be sent to the National Register Office. Results would probably be known in early January, 2021.
