 The Economic Development Revolving Loan Fund currently has two outstanding loans in default in December 2019 and principal payment was made to participating banks

 Description:
 from the Loan Loss Reserve in December 2020. It was initially thought that only principal was due to participating institutions, but further review of relevant agreements revealed that interest payout should also be included. Interest payments on one of the defaulted loans amount to a total of \$46,954.39, payment of which will be divided between 7 participation shares. Interest payments have not been paid to participants at this point because they require a budget adjustment.

Another loan is over 12 months behind on payments, which necessitates payout to the participating banks, per the Master Participation Agreement. The outstanding principal balance which will be charged to the Loan Loss Reserve is \$128,946.74 (payment of which will be divided between 7 participation shares). Recent payments from this loan have paid off all accumulated interest, so there is no interest portion to pay out on this loan.

Together, a budget adjustment totaling \$175,901.13 is required to charge off the two outstanding loans and pay out the participating banks for their shares.
